SAILING INSTRUCTIONS

1 RULES

1.1 The event is governed by the *rules* as defined in *The Racing Rules of Sailing (RRS)*.

1.2 The notation "[DP]" in a rule in these Sailing Instructions means that the penalty for a breach of a rule may, at the discretion of the protest committee, be less than disqualification.

2 CHANGES TO SAILING INSTRUCTIONS

2.1 Any change to the sailing instructions will be posted before 0800 on the day it will take effect, except that any change to the schedule of races will be posted by 2000 on the day before it will take effect.

2.2 Changes to a sailing instruction may be made on the water by contacting the specific class(s) affected by VHF notifying of the change.

3 COMMUNICATIONS WITH COMPETITORS

3.1 Notices to competitors will be posted on the official notice board located at the official regatta website located at: <u>News Room.</u>

3.2 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

3.3 Competitors using the RaceQs tracking app may be used for verifying finish times & order and obstruction intrusion.

4 CODE OF CONDUCT

4.1 [DP] Competitors and support persons shall comply with reasonable requests from race officials.

4.2 [DP] Competitors and support persons shall handle any equipment provided by the organizing authority with care, seamanship, in accordance with any instructions for its use and without interfering with its functionality.

5 SIGNALS MADE ASHORE

5.1 Signals made ashore will be displayed on the official notice board located at the official regatta website located at <u>News Room</u>

5.2 When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 60 minutes' in Race Signals AP.

5.3 In the event of signals made ashore, the Race Committee <u>may</u> also notify participants via SMS text message to the number provided at registration.

7 CLASS FLAGS

7.1 The class flags are as follows:

Double-handed PHRF Spinnaker	White Flag
Double-handed PHRF Non-Spinnaker	Dark Flag
Cruising Club	Orange

7.2 It is recommended for each competitor to display a class flag.

8 RACING AREA

8.1 SI Addendum #1 shows the location of the racing area.

9 COURSES

9.1 SI Attachment #1 shows an illustration of the course.

9.2 **Two¹** 'laps' of the course are required by each boat in the manner of her choosing as described below (for example, one lap is comprised of 1-A/1-B):

<u>1-A</u>. Sail to E, H or J via 2A. Round Mark to Port.

<u>1-B</u>. Sail back to and the Start/Finish Line from the direction of the last mark (i.e. reverse of 1-A). Round start marks to starboard or to port.

<u>2-A</u>. Sail to either of the two remaining Marks not yet rounded (E, H, or J via 2A). Round Mark to Port.

<u>2-B.</u> Sail back to Finish. (i.e. reverse of 2-A)

¹ This is a modified course from the traditional Conundrum Regatta

* Note: The San Leon Oyster Mitigation 2A must be honoured going to and from J mark.

* Note: When rounding Kemah Channel Marks #1 & #2, stay aware of boats using the channel.

10 MARKS

10.1 Mark(s) (is)are fixed Galveston Bay markers.

- **10.2** The following marks are starting marks:
 - Kemah Channel #1
 - Kemah Channel #2
 - Vessels shall exercise caution: there may be remnants of the original #2 (pilings) about 10' to south of current #2.

11 **OBSTRUCTIONS**

11.1 The following areas are designated as an obstruction:

11.1.1 The Houston Ship Channel. Reference is made to NOAA Electronic Navigational Chart US5TX54M, Upper Galveston Bay-Houston Ship Channel-Dollar Pt. to Atkinson (1/29/2021).

11.1.2 San Leon Oyster Mitigation Reef encompassed by the following points and represented in SI Addendum #1:

- 29°32.310'N, 94°56.817'W
- 29°31.845'N, 94°56.305'W
- 29°31.387'N, 94°56.738'W
- 29°31.128'N, 94°57.767'W
- 29°31.172'N, 94°58.885'W
- 29°31.463'N, 94°59.115'W
- 29°32.027'N, 94°58.372'W

And the shoreline perpendicular to these points

12 THE START

12.1 Races will be started via Pursuit style with the base rating at 215.

12.2 The start time matrix (SI Attachment #2) will be based off the shortest two legs at a length of 12.18 nm.

12.2 The starting line is between Kemah Channel #1 as the starboard end and Kemah Channel #2 as the port-end starting mark.

12.3 A committee boat may be monitoring any mark of the course verifying marks (including virtual) are being honoured, as well as the starting area monitoring starting times. If any part of a boat's hull is on the course side of the starting line at her starting signal and she is identified, the race committee may attempt to hail her sail number. Failure to hail her number, failure of her to hear such a hail, or the order in which boats are hailed will not be grounds for a request for redress. This changes RRS 62.1(a).

12.5 A boat that does not start within **30** minutes after her starting signal will be scored Did Not Start without a hearing. This changes RRS A5.1 and A5.2.

13 THE FINISH

13.1 The finishing line is between Kemah Channel #1 and #2. (Same as Icicle and Rum Races).

13.2 Finishes shall be entered in the following link: FINISHING

14 PENALTY SYSTEM

14.1 The first two sentences of RRS 44.1 are changed to:

A boat may take a One-Turn Penalty when she may have broken one or more rules of Part 2 or Rule 31 in an incident while racing. However, when she may have broken one or more rules of Part 2 while in the zone around a mark other than a starting mark, her penalty shall be a Two-Turns Penalty.

14.2 Alternatively, a boat may accept a Scoring Penalty as described in RRS 44.3. The Scoring Penalty shall be 20% of the boats entered unless the incident occurred within the zone of any mark, in which case the scoring penalty shall be 40% of the boats entered.

15 TIME LIMITS [AND TARGET TIMES]

15.1 The time limit for all classes to complete the race shall be sunset.

16 HEARING REQUESTS

16.1 The protest time limit is 60 minutes after the race committee arrives at the GBCA Clubhouse. These times will be posted on the official notice board.

16.2 Paper hearing request forms are available from the GBCA clubhouse, however electronic filings using the US Sailing app are preferred by the protest committee. Please forward all filings to RaceCommitteeTX@gmail.com.

16.3 The protest committee will endeavour to post the notice of protests and the hearing schedule within 30 minutes after the close of the deadline for filing protests. Notices and schedules will be posted using the Regatta Network official notice board at: <u>Notice Board</u>

16.4. Notices of protests by the race committee, or protest committee will be posted to inform boats under RRS 61.1(b).

16.5 Breaches of Sailing Instructions 6.2, 24, 25, 26, and 27 will not be grounds for a protest or request for redress by a boat. This changes RRS 60.1(a)

16.6 **RRS** 62.2(a) and 66.2(a) do not apply.

16.7 The US Sailing prescription to RRS 63.2 does not apply.

17 SCORING

17.1 One race is scheduled and shall constitute the regatta.

18 SAFETY REGULATIONS

18.1 [DP] A boat that retires from a race shall notify the race committee at the first reasonable opportunity by cell phone and/or text message.

19 EQUIPMENT AND MEASUREMENT CHECKS

19.1 A boat or equipment may be inspected at any time for compliance with the class rules, notice of race and sailing instructions.

20 OFFICIAL VESSELS

20.1 Official vessels will be identified with GBCA burgee.

21 TRASH DISPOSAL

21.1 Trash may be placed aboard official [or support person] vessels, or properly disposed ashore.

22 PRIZES

22.1 Prizes will be given for 1st through 3rd places in each class based on number of entries as detailed in the Notice of Race.

22.2 The first competitor to finish in either the PHRF Double Spin, or PHRF Double Non-Spin shall be awarded the J. Kevin Box Memorial Perpetual Trophy.

23 RISK STATEMENT

23.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

24 INSURANCE

24.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$300,000 per incident or the equivalent.
