NOTICE OF RACE As Amended April 1, 2024

Changes in RED

1. RULES

- 1.1 The regatta shall be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

2. SAILING INSTRUCTIONS

The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing Instructions, and supplementary sailing instructions posted on the official notice board located adjacent to the HYC Office.

3. ELIGIBILITY, REGISTRATION, & FEES

- 3.1 The event is open to all keel, multihull, and centerboard boats.
- 3.2 There is no fee for entry in the Wednesday Night Series.
- 3.3 Boats may register at www.regattanetwork.com/event/27576.
- 3.4 Non-Members planning to race in the Wednesday Night Series must fill out the **Summer Parking Request** form and turn it in to the HYC Main Desk upon arrival at Houston Yacht Club.
- 3.5 The charge for Non-Member parking from Mar-24 through Sep-20 is \$350.00.
- 3.6 Non-members must provide a copy of their liability insurance along with the form.

4. SCHEDULE

- 4.2 The scheduled time of the warning signal for the first race each day is:
 - a. **6:00 PM** for the Ensign class and the Melges-15 class.
 - b. **6:15 PM** for all other classes.
- 4.3 No warning signal will be made less than 40 minutes prior to Actual Sunset.

5. VENUE

Races shall be held adjacent to Houston Yacht Club on Upper Galveston Bay in the recreational area North of the Bayport Shipping Channel and bounded by the Houston Shipping Channel to the East.

6. RISK STATEMENT

Competitors participate in the regatta entirely at their own risk. See RRS 3, *Decision to Race*. The organizing authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

7. INSURANCE

[NP] Each participating boat shall be insured with valid third-party liability insurance with a minimum coverage of \$300,000.00 per incident or the equivalent.
