

Neuse Yacht Racing Association Commodore's Regatta 2024

NOTICE OF RACE

The Neuse Yacht Racing Association (NYRA) is the Organizing Authority for this regatta.

1. RULES:

- 1.1. The Regatta will be governed by the current Racing Rules of Sailing; the prescriptions of USSailing; the N.C. Wildlife Commission; and U.S. Coast Guard safety regulations.
- 1.2. The Navigator (formerly Cruising) Fleet entrants must adhere to the "Rules Governing Cruising Fleet Boats for ICRC Races (see Attachment 1)
- 1.3.RRS 26 is changed for the NavigatorFleet starts.
- 1.4.RRS Appendix T Arbitration applies.
- 1.5. RRS Appendix V Alternative Penalties, Section V1 applies.

2. ELIGIBILITY:

- 2.1. The regatta is open to sailboats 21 feet or longer LOA with a current NC PHRF rating certificate.
- 2.2. NC PHRF rating certificates may be obtained at www.ncphrf.com.

 Completed and signed Applications must be received no later than 1 week prior to the regatta. A provisional/temporary PHRF certificate may be issued dependent upon sufficient warning prior to the start of the regatta.

3. ENTRY AND REGISTRATION:

- 3.1. Anticipated fleets are Spinnaker, Non-spinnaker, and Navigator Class.
- 3.2 Eligible boats may enter by registering online at NYRA's Regatta Network page for this event. https://www.regattanetwork.com/event/27618

4. FEES:

- 4.1. Fees for competing and social event are described on the Registration Form attached hereto.
- 4.2. Members of US Sailing receive a \$5 discount, and NYRA members receive a \$5 discount.

5. SCHEDULE:

Saturday February 17

- 0900 Competitor's meeting at Blackbeard Sailing Club
- 1055 First signal for racing
- 1800 Shore Party and Annual Awards Ceremony at Confluence at the Double Tree (Lawson Room).

6. SAILING INSTRUCTIONS:

Sailing Instructions will be posted on the event page on Regatta Network by or before 1200 Friday, February 16th.

7. COURSES

- 7.1. Courses to be sailed will be defined in the Sailing Instructions. All courses will be sailed on the Neuse River southerly of Duck Creek and in the general vicinity of Broad and Northwest Creeks.
- 7.2. Spinnaker and Non Spinnaker fleets will sail either Windward/Leeward or Triangle courses.
- 7.3. The Navigator will sail a medium distance race with a modified pursuit start
- 7.4.Dependent on the number of entrants and differences in ratings, the Navigator Class may be divided into rating bands, each of which will have its own start.
- 7.5. All starts and finishes will be recorded by the Race Committee

8. SCORING AND HANDICAPS:

- 8.1. The Low Point System as described in Appendix A of the RRS will be used for scoring.
- 8.2. Corrected scores will be determined using time-on-time calculation.
- 8.3. Class splits for Spinnaker and Non-Spinnaker classes will be dependent upon entries. There will be no class splits in the Navigator Fleet.
- 8.4 One completed race will constitute the regatta.

9. PRIZES:

- 9.1. Prizes for the regatta will be awarded based on number of entries in each class and fleet.
- 9.3 2023-24 Winter Series awards, together with Boat of the Year, Crew of the Year, and Sportsman of the Year awards will be presented at the Commodores Regatta Dinner on February 17, 2024.

10. SAFETY CONDITIONS AND ABANDONMENT:

- 10.1.Racing may be canceled or abandoned at the discretion of the PRO at any time prior to or during racing.
- 10.2. Notice of any cancelation prior to race day will be sent to all registered skippers via email as soon as the determination has been made.

11. INSURANCE, SAFETY & DISCLAIMER OF LIABILITY:

- 11.1.Each participating boat must be insured with an adequate valid third-party liability policy.
- 11.2.RRS 3 states: "The responsibility for a boat's decision to participate in a race or to continue to race is hers alone." By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling error, poor seamanship by other boats, loss of balance on an unstable platform, and fatigue resulting in increases risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia, or other causes.

12. DOCKAGE:

The OA will attempt to find local dockage for any boats wishing to travel from other areas to sail in this regatta. Contact the board at if interested.

ATTACHMENT "A"

RULES GOVERNING NAVIGATOR CLASS RACES

NYRA recognizes the need to make accommodation for boat owners who may not wish to maintain their boat at the performance level implied by a standard NC-PHRF certificate. These boats are welcome to race in Navigator Class. Therefore, the following guidelines are issued for those boats.

- 1. No boats specifically designed for racing are allowed.
- 2. Only Dacron sails are allowed. No spinnakers are allowed.
- 3. Powered winches are allowed.
- 4. Each boat shall have a current NC-PHRF rating certificate.
- 5. Two of the four following additional Cruising Class requirements will be met, based on the statements of the boat owner at the time of registration.
 - a. Windlass or pulpit mounted anchor
 - b. Dodger/Bimini in place
 - c. The youngest sail to be 5 years old or older
 - d. Bottom paint 3 years old or older
