Notice of Race Koko Head Race

Sunday, February 18, 2024

Organizing Authority: Hawaii Yacht Club (HYC)

1. RULES

The race will be governed by the rules as defined in *The Racing Rules of Sailing 2021-2024*, including US Sailing Prescriptions and Hawaii Yacht Racing Association [HYRA] Prescriptions unless otherwise amended in this Notice of Race or the Sailing Instructions.

2. <u>ADVERTISING</u> Shall comply with ISAF Regulation 20. Competitor advertising will not be restricted.

3. ELIGIBILITY AND ENTRY

- **3.1.** The regatta is open to all yachts that are members of HYRA member clubs, and other yachts that may be invited by the organizing authorities.
- **3.2.** Eligible yachts may enter via the US Sailing RegattaNetwork website. http://www.regattanetwork.com/html/ calendar.html.

6. MEASUREMENTS

Each boat shall have a valid YRA / NCPHRF Northern California Performance Handicap Racing Fleet handicap certificate or be assigned a temporary handicap. The NCPHRF certificate application can be found at www.yraa.org

7. SAILING INSTRUCTIONS

Sailing instructions will be available at the skippers' meeting and on RegattaNetwork.

8. VENUE

The race will be in Mamala Bay and Maunalua Bay, between Ala Wai Harbor and Kokohead.

9. SCORING

- **9.1.** Corrected times will be calculated using the PHRF Time-on-Time scoring system, as adopted by HYRA.
- **9.2.** The low point system of RRS Appendix A shall apply without modification.

10. PRIZES

For each class a first prize will be awarded if at least three boats enter, second prize will be awarded if at least five boats enter, and third prize will be awarded if at least seven boats enter.

11. DISCLAIMER OF LIABILITY

The responsibility for a boat's decision to participate in a race or the continue racing is hers alone. See RRS Rule 4, Decision to Race. The organizing authority will not accept liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

12. INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$500,000 per event or the equivalent. A copy of certificate will be required at time of registration.
