1. Rules

- 1.1. The race will be governed by the rules as defined in The Racing Rules of Sailing 2021-2024 unless otherwise amended in this Notice of Race or the Sailing Instructions.

2. Advertising

- 2.1. Competitor advertising will not be restricted.

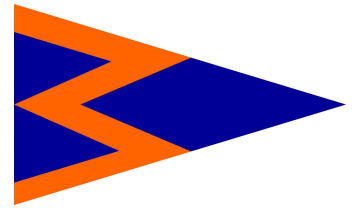
3. Eligibility and Entry

- 3.1. The regatta is open to all yachts that are members of HYRA member clubs, and other yachts that may be invited by the organizing authorities.
- 3.2. Eligible yachts may enter via the US Sailing Regatta Network website. Entries will only be accepted using the Regatta Network website <http://www.regattanetwork.com/html/calendar.html>.
- 3.3. A representative from each competing yacht **shall** attend the skippers meeting to be eligible to race.

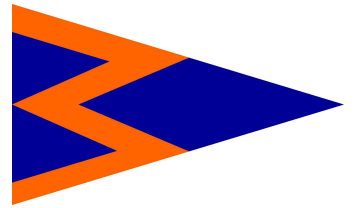

6. Measurements

- 6.1. Each boat shall have a valid YRA / NCPHRF Northern California Performance Handicap Racing Fleet handicap certificate or can be assigned a temporary handicap for this race only. The NCPHRF certificate application can be found at WWW.YRA.org.

7. Sailing Instructions

- 7.1. Sailing instructions will be available at the skippers meeting and on Regatta Network.

8. Venue

- 8.1. The race will be held in Mamala Bay.

9. Scoring

- 9.1. Corrected times will be calculated using the PHRF Time-on-Time scoring system, as adopted by HYRA.
- 9.2. The low point system of RRS Appendix A shall apply without modification.

10. Prizes

- 10.1. Prizes will be awarded for winners of each class. All boats will be recognized for the donations they raised.

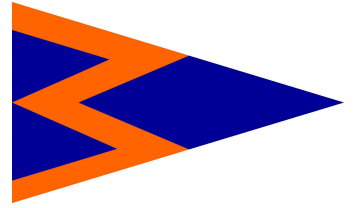
11. Disclaimer of Liability

- 11.1. The responsibility for a boat's decision to participate in a race or the continue racing is hers alone. See RRS Rule 4, Decision to Race. The organizing authority will not accept liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

12. Insurance

- 12.1. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$500,000 per event or the equivalent. A copy of certificate will be required at time of registration.
