## **NOTICE OF RACE**

### **1) RULES**

- a) The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* and including the [DragonFlite 95 Restricted Class Rules](#) (DF95-RCR).
- b) RRS Appendix E will apply.

### **2) ELIGIBILITY AND ENTRY**

- a) The regatta is open to all DragonFlite 95 skippers who are current members of The AMYA, or their foreign international RC Sailing Association. AMYA Membership applications will be available at check in.
- b) Eligible competitors may register by completing [the online entry form](#).
- b) Entry forms and fees are due by April 10th at 1200 hours.
- c) Late entries may be accepted at the discretion of the Race Committee.
- d) The following restrictions on the number of boats apply: Fifty (50). A waiting list will be established, and the Race Committee reserves the right to increase the number of competitors.

### **3) FEES**

- a) The entry fee of \$60 is due at the time of registration and includes lunch on Saturday and Sunday along with 2 drink tickets.
- b) Immediately following racing on Saturday we will have free appetizers and free keg beer available for participants either by the LYC pool or at the upper deck area.

The organizing authority, Bay Access Sailing Foundation, will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
