

Notice of Race 2024 Carter Lake Sailing Club Open Regatta & Santana 20 Mountain Regional Championship

- 1.EVENTS The Carter Lake Sailing Club (CLSC) will conduct the 65th Carter Lake Open Regatta and the Santana 20 Mountain Regional Championship at Carter Lake, Loveland, Colo., on Saturday, June 1, and Sunday, June 2, 2024. CLSC is the Organizing Authority.
- **2. RULES** These Regattas will be governed by the rules as defined by the 2021-2024 Racing Rules of Sailing (RRS) except as changed by this NOR, the Sailing Instructions, the Rules & Regulations of Larimer County, and all guidelines, federal, state, and county.
- **3. SAILING INSTRUCTIONS** Sailing Instructions (SIs) will be available at on-site registration and at the competitor's meeting on Saturday, June 1. SIs may be posted on the CLSC website, www.sailcarter.org, on or before Friday, May 31.

4. ELIGIBILITY AND ENTRY

- 4.1 The **Carter Lake Sailing Club Open Regatta** is open to all PHRF and Portsmouth rated boats. One Design fleets with three (3) or more boats will be recognized as a fleet/class. Additional classes/fleets may be established at the discretion of the Race Committee (RC). Classes may be formed into divisions for starting & courses.
- 4.2 Eligibility requirements for boats include that they be currently registered in their state of origin, display their current registration, and have paid their entry fees. Boats that have not registered, not paid their entry fee and not signed their waivers will not be considered competitors.
 - 4.2.1 Boats not registered or who have not paid the entry fee will not be considered competitors.
 - 4.2.2 PHRF classes are defined as follows:

PHRF Class A PHRF ratings 195 and lower PHRF Class B PHRF ratings 196 and higher

- 4.2.3 The S.A.I.L. PHRF Committee is the authority for interpreting the PHRF rules and issuing certificates. Boats racing PHRF shall have a current SAIL PHRF certificate. Temporary PHRF ratings for non-S.A.I.L. members will be assigned by the RC and are not subject to appeal.
- 4.3 The **Santana 20 Mountain Regional Championship** is open to all Santana 20s that present a current Class membership certificate, four measured and stamped sails, and sail all races with a current class member aboard. Measurement and membership must be dated by May 30 or before.
 - 4.3.1 Santana 20 equipment and racing is governed by the current Santana 20 Class Association Handbook available for download on *S20.org*.

- 4.3.2 The **Santana 20 Mountain Regional Championship** will serve as a sanctioned event for the Santana 20 Class. Boats that have not registered, not paid their entry fee and not signed their waivers will not be considered competitors.
- 4.4 All competitors are encouraged to pre-register online at www.regattanetwork.com To pre-register on the Regatta Network web site, click on the "Calendar" tab found on the far left of the dark blue bar. Once the calendar appears, scroll to the date 06/1/24 and CLSC Open Regatta. Click on "Register Online" to the right of the date and event name.
- 4.5 On-site registration will be available on Friday afternoon and Saturday morning at the Carter Lake Sail Club Clubhouse.
- 4.6 All registrants must go check in on site at the registration desk to pick up their Sailing Instructions and sign their waivers. Boats that have not registered, not paid their entry fee and not signed their waivers will not be considered competitors.
- **5. FEES** The Regatta entry fee is \$70 paid by May 16, 2024, and \$85 after May 16, 2024. Entry fees do not include the required Larimer County Park Passes for vehicles and boats. Park Pass fees must be paid at the Marina or Park entry station. Entry fees include Saturday breakfast, Sunday breakfast and snacks at Awards Ceremony.

6. SCHEDULE

Friday, May 31, 2024

Saturday, June 1, 2024

On-Site Registration: 9:00 - 9:45 a.m. 10:00 a.m.: Competitors meeting

11:25 a.m.: First warning signal with subsequent signals and races to follow

6:00 p.m.: Saturday evening social and dinner

Sunday, June 2, 2024

9:55 a.m.: First warning signal. Subsequent signals and races to follow.

No race warning after 2:30 p.m.

An awards ceremony will take place at the club house as soon as possible after the finish of the last race.

- **7. NOTICES TO COMPETITORS** Notices to Competitors will be posted at the CLSC club house.
- **8. PRIZES** Trophies will be awarded based on the number of competitors in each class:

Fleets with three boats will have a first-place trophy awarded.

Fleets with four boats will have a first- and second-place trophy awarded.

Fleets with five or more boats will have a first-, second- and third-place trophy awarded.

Additional prizes may be awarded at the organizing authority's discretion.

9. VENUE All races will be conducted on Carter Lake, Loveland, Colo.

10. SCORING

- 10.1 The Low Point Scoring System in the RRS Appendix A will be used subject to modifications in the Sailing Instructions.
- 10.2 The Race Committee will assign handicaps for boats entering the handicap (PHRF) class without S.A.I.L. PHRF certificates, not subject to appeal.

- 11. DISCLAIMER OF LAIBILITY Competitors in this regatta are participating entirely at their own risk. See RRS Rule 4: Decision to Race. The Regatta Organizers—Organizing Authority, Race Committee, Protest Committee, host club, sponsors, and/or any other organization or official—will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to provide a signed release to the Regatta Organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by the law. Juniors must provide a signed release from a parent or legal guardian.
