1. RULES

- 1.1.RRS 61.1(a) is changed as follows: Add a fourth sentence that reads, 'She shall inform the Race Committee immediately after finishing, or as soon as practicable after she retires, of the boat(s) she intends to protest'.
- 1.2. The following prescriptions of US Sailing do not apply: RRS 63.1 and RRS 63.2.

2. SAILING INSTRUCTIONS

2.1. The Sailing Instructions will be posted at least 24 hours prior to the event on the SSA website (www.sandpointsailing.org) and will also be available at registration.

3. COMMUNICATION

- 3.1. The official notice board is located at Fred's Deck.
- 3.2. While participating, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4. ELIGIBILITY AND ENTRY

- 4.1. The regatta is open to all boats in a One-Design class of at least 5 boats, boats sailing in the Cruising class, and boats with a valid PHRF rating.
- 4.2. The PHRF of the Pacific North-West handicap system applies to boats racing in the PHRF Classes. If you do not have a rating, you will be assigned a rating per PHRF North-West. Other-wise bring documentation of your PHRF North-West Rating certificate.
- 4.3. Eligible boats may register online at: https://www.regattanetwork.com/event/28503 or by completing the form in NoR Addendum A and sending it, together with proof of insurance and the required fee.
- 4.4. Entries will not be accepted after 0830 on August 31st 2024.

5. FEES

- 5.1. Entry fees are as follows: \$190 for 2 crew members, \$260 for 4 crew members
- 5.2. The entry fee includes complimentary boat moorage for the duration of the event, meal tickets for respected number of crew, 2 drink tickets for respected crew, and one appetizer.
- 5.3. Dinner tickets for additional persons for Saturday night are available for \$35 each on Regatta network storefront. Tickets will not be available at the event.

6. SCHEDULE

6.1. Registration and dates of racing for all classes:

7. VENUE

7.1. NoR Addendum B shows the location of Windbag Marina.

7.2. NoR Addendum C shows the location of the racing area on Lake Pend Oreille adjacent to SSA.

8. COURSES

- 8.1. The courses to be sailed will be around marks set by the race committee and may include windward, leeward and reaching legs.
- 8.2. The regatta will include long distance courses for the Long Distance Racing Class.

9. SAFETY

9.1.A boat that retires from a race shall notify the race committee at the first reasonable opportunity.

10. SCORING

- 10.1. Three (3) races are required to be completed to constitute a regatta and a maximum of twelve (12) races are scheduled for each class.
- 10.2.One-Design classes will be scored in order of finish.
- 10.3.PHRF and Cruising classes will be scored using Time-on-Time.

11.BERTHING

- 11.1.[DP] Visitors may use the west side of the 700 dock.
- 11.2.[DP] Visitors shall keep docks clear of equipment while sailing.

12. PRIZES

- 12.1. Prizes will be awarded to the top three (3) boats based in each class.
- 12.2. The Spud Cup Trophy award will be determined by a committee of past Spud Cup winners and will be based on finishing place in class and sportsmanship. This changes RRS 90.3 and RRS A4.

13. DISCLAIMER OF LIABILITY & PERSONAL CONDUCT

13.1.Competitors participate in the regatta at their own risk. See RRS 3, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

13.2.[DP] By participating in this regatta competitors, and their support person(s), agree to accept the rules (RRS 4, Acceptance of the Rules). These include the rules published in the Racing Rules of Sailing, this Notice of Race, and the Sailing Instructions, including those related to safety, participation, and personal conduct. Competitors and any Support Person will accept full responsibility of their actions during any activity related to this event. This includes onshore activities before, during, and after the regatta.

14. INSURANCE

14.1.[DP] Each participating boat shall be insured with valid third-party liability insurance with a minimum coverage of \$100,000.


