1 RULES

- **1.1** This race will be governed by the rules as defined in *The Racing Rules of Sailing*.
- **1.2** RRS 40.1 applies.
- **1.3** U.S. Prescriptions to RRS 63.2 and 63.4 are deleted.

2 ELIGIBILITY AND ENTRY

- 2.1 In accordance with rule 75.1 boats must be entered by competitors who are members of appropriate sailing clubs. Those failing to comply are encouraged to join the Tahoe Yacht Club. Another alternative would be to join the Scuttlebutt Sailing Club at no charge:

- 2.2 This series is open to any keelboat or multi-hull with an LOA of 18 feet or greater.
- **2.3** Boats shall hold a current PHRF rating from the Lake Tahoe PHRF Committee.
- **2.4** Eligible boats may be entered online not later than 1200 hours, 7/28/24: http://www.regattanetwork.com/event/28530.

6 VENUE

6.1 The racing venue will be on the waters of Lake Tahoe, off the shores of Gar Woods Restaurant in Carnelian Bay.

7 SCORING

Races will be scored using the Tahoe PHRF Handicap System with Time-on-Time scoring as described by US Sailing: http://www.ussailing.org/competition/offshore/phrf

TCF = A/(B + PHRF)

Where A = 650

Where B will be assigned by the race committee:

B = 480 for heavy air, 550 for average conditions, 600 for very light air.

8 PRIZES

- **8.1** Prizes will be awarded based on entries.
- **8.2** Competitors are encouraged to attend the awards presentation at Gar Woods Restaurant shortly after the last boat finishes.
