# CONGRATULATIONS! YOU HAVE BEEN SELECTED TO PARTICIPATE IN THE 2010 U.S. YOUTH SAILING CHAMPIONSHIP AT THE CABRILLO BEACH YACHT CLUB!

You have been selected not only on your sailing ability, but your commitment to improving in the sport, as demonstrated through the amount and quality of your training. # **REGISTRATION AND PAYMENT DEADLINES:**

NOTE: If you are in a doublehanded boat, see the DOUBLEHANDED TEAMS section for further instructions.

- 1. ONLINE REGISTRATION and PAYMENT due by May 15, 2010:
  - From the US SAILING website <u>http://championships.ussailing.org/Youth/US Youth Champs.htm</u> complete the online registration form and pay the entry fee of \$350 per competitor via credit card.
  - You will need to include your travel information.
  - You will get an e-receipt if your form went through correctly. Save this, as it will contain a link for you to go in and update your flight plans if something changes.
  - Incomplete entries will be deleted on May 16 and we will move you to the bottom of the waiting list.
- 2. <u>REGISTRATION FORMS postmarked by May 15, 2010:</u>

- 3. OTHER NOTIFICATION

- Mail completed forms to Cortney Medak, 2010 U.S. Youth Sailing Championship, 211 West 22<sup>nd</sup> Street, San Pedro, California 90731 – again, postmarked by May 15, 2010. Do NOT send them to US SAILING.

Any changes to your entry information <u>after</u> May 15, 2010 must be communicated via e-mail to the US SAILING, CBYC Regatta, and CBYC Registration Chairmen.

If you have been approved for a charter, refer to the website you have been given separately for payment information.

# No exceptions!

#### WITHDRAWALS:

<u>UNTIL May 15:</u> You can withdraw from the regatta *without penalty* until May 15th; even if you have already sent your entry/charter fees. Communicate via e-mail to the US SAILING, CBYC Regatta, and CBYC Registration Chairmen that you no longer plan to compete and no longer need a charter boat, if applicable. Before May 15th, your entire respective entry fee will be refunded without penalty. US SAILING will endeavor to find a substitute for your charter. If that can be done, your charter fee will also be refunded.

• <u>AFTER May 15:</u> If you withdraw from the regatta or do not need a charter boat, communicate via e-mail to the US SAILING, CBYC Regatta, and CBYC Registration Chairmen. After May 15, your entry fee and your charter fee are NOT refundable.

### **DOUBLEHANDED TEAMS:**

- <u>FORMS</u>: BOTH skipper and crew must complete the Online Registration and send in ALL forms together. (Acceptance letters and forms have been sent to both skipper and crew, so there is no need to make copies.) Please send both sets of forms and fees together in the same envelope whenever possible. We will not alert you to the fact that your sailing partner has not sent in his/her forms. This is solely the responsibility of the competitors. We will endeavor to update the registration site on a regular basis to show which boats are complete and what materials, if any are missing.
- <u>CREW CHANGES</u>: Occasionally, unanticipated situations may make it necessary for teams in the doublehanded divisions to change crew. Crew changes will be granted *only if* there is a valid reason. Sailors who wish to change sailing partners must submit a request in writing, stating the reason. Send your request via e-mail to Shannon Bush, U.S. Youth Sailing Championship Committee Chairman, (<u>swmadero@aol.com</u>).
  - Unjustified crew changes, without first receiving written permission from US SAILING, will not be allowed. We encourage you to plan well in advance in an effort to retain your original team unless a true emergency arises.

# **ARRIVAL AT THE SAILING SITE:**

# NOTE: No early arrival of boats or sailors will be allowed.

- <u>VENUE</u>: All registration, sailing activities, charter boats, and breakfast will be located at Cabrillo Beach Yacht Club in San Pedro, California. Social events will be based out of Cabrillo Beach Yacht Club.
- <u>COMPETITORS AND EQUIPMENT</u>: NO ONE, except CBYC members, may be at CBYC 2 weeks before the event and are to arrive AFTER Sunday, August 1 at 1000. Being "invited" by a CBYC member *is not* an exception to this rule. No housing will be provided to anyone arriving before Sunday, August 1, 2010.
- <u>EVENT REGISTRATION</u>: Event registration at Cabrillo Beach Yacht Club will be from 1000-1600 on Sunday, August 1.

# **AIR TRAVEL INFORMATION:**

NOTE: It is imperative that you include the arrival and departure data in online registration forms that must be received by May 15, 2010. We encourage you to have a cell phone with you when you travel to assist with travel coordination.

# AIRPORT INFORMATION:

Los Angeles International Airport (LAX) is 21 miles and approximately 30 minutes (without traffic) from CBYC. Ground Transportation will be arranged for the competitors between 0900 – 1400 from LAX. See the ARRIVAL INFORMATION - GROUND TRANSPORTATION section below. IF YOU ARE NOT ARRIVING AT LAX OR YOU ARRIVE AT LAX BEFORE 0900 OR

Long Beach Airport (LGB) is 16 miles and approximately 20 minutes (without traffic) from CBYC. Ground Transportation will be arranged for the competitors between 0900 – 1400 from LGB. See the ARRIVAL INFORMATION - GROUND TRANSPORTATION section below. IF YOU ARE NOT ARRIVING AT LGB OR YOU ARRIVE AT LGB BEFORE 0900 OR AFTER 1400, GO ONLINE FOR FURTHER INFORMATION WHICH WILL BE POSTED SHORTLY: www.usyouthchamps.com

- <u>AIRLINES:</u>
- LAX: All major airlines service Los Angeles International Airport (LAX). This year, US SAILING has again worked with United Airlines to arrange a discount for travel that you might wish to explore. This code only works on championships
- LGB: Airline servicing Long Beach Airport (LGB) include: Alaskan Air (Horizon Air), Delta, JetBlue, and US Airways.
- <u>SCHEDULING</u>: Competitors should schedule their flights to arrive at LAX or LGB after 0900 and before 1400 on Sunday, August 1, 2010. If there is a problem meeting this schedule, contact CBYC Transportation Chairman @transportation@cbyc.org. NO DEPARTURE FLIGHTS SHOULD BE SCHEDULED BEFORE 2100 ON WEDNESDAY, AUGUST 4.

If you are traveling as an Unaccompanied Minor, you must let the CBYC Transportation Chairman know via e-mail, so that someone can be assigned to sign for you. There is a space on your online registration to notify us as well.

- ARRIVAL INFORMATION:
  - If your flight is delayed, call the CBYC Transportation Hotline at (310) 498-4512 immediately.
  - Upon arrival, call the CBYC Transportation Hotline at (310) 498-4512 to confirm your arrival.
  - If you are using CBYC's arranged Ground Transportation from LAX, proceed to the baggage claim area, pick up your bags and proceed to the Shuttle pickup outside and across the street to where a CBYC representative will be there to greet you and help you board the Supper Shuttle Van.
  - If you are using CBYC's arranged Ground Transportation from LBG, proceed to the baggage claim area where the CBYC representative will be there to greet you and direct you to the transportation pick up.
  - GROUND TRANSPORTATION:
    - CBYC is currently arranging for group Ground Transportation for those arriving at LAX or LGB between 0900 – 1400. Go online for further information which will be posted shortly: <u>www.usyouthchamps.com</u>.
  - FOR YOUR OWN SAFETY, <u>DO NOT</u> ACCEPT RIDES OR TRANSPORTATION AT LAX or LGB that has not been arranged by CBYC.

• Competitors will be met by their Host Housing parent at Cabrillo Beach Yacht Club. You will only find out who your housing host is at registration.

If there is a flight delay or travel problem during your trip, contact the **CBYC Transportation Hotline** at (310) 498-4512.

- DEPARTURE INFORMATION:
  - No departure flights should be scheduled before 2100 on Wednesday, August 4. Traffic in the Los Angeles area is such that it can take up to one hour to get to the airport and we don't want you to miss your flight.
  - <u>GROUND TRANSPORTATION</u>: CBYC is currently arranging group Ground Transportation from CBYC to LAX or LGB. Go online for further information which will be posted shortly: <u>www.usyouthchamps.com</u>.
  - Vans will depart from CBYC after 1900 on Wednesday August 4. Earlier or later transportation will not be available. Costs of the van will be posted online at <u>www.usyouthchamps.com</u>. Please ensure you have enough money for your return trip.
  - If you are traveling as an Unaccompanied Minor, check with your airline to see if it will accept credit cards to pay the required fee at check in. Otherwise ensure that you have either traveler's checks or cash.
- TRAVEL QUESTIONS OR DELAYS:
  - Refer to the event website for further travel information and updates.
  - <u>QUESTIONS</u>: Any questions regarding transportation, airlines or airports should be directed to the Transportation Chairman, Erin O'Connell at transportation@cbyc.org. Every question or concern will be answered promptly.
  - <u>TRAVEL CHANGES due no later than Thursday, July 15</u>: You can go into your registration using the link you were provided and update your travel plans at any point up to July 15. If your plans change <u>after that</u>, *send an e-mail* to the Transportation Chairman at transportation@cbyc.org, *entitled: "Travel Changes"*. We will be tracking the arrival of each person carefully.

# **DEPARTURE FROM THE SAILING SITE:**

- Competitors will not be allowed to depart for any reason prior to the Awards Ceremony, Wednesday, August 4, 2010.
- All boats and trailers must depart by 1700 on Thursday, August 5, 2010.

# CHARTER BOATS:

 Competitors who are approved for an official charter boat will have an additional letter with detailed information enclosed in this packet. Please read it carefully so that you will know exactly what you will need to bring. Charter fees must be paid online by the stated deadlines. Refundable damage deposits will be paid by credit card to LaserPerformance and the damage deposit forms must be on file prior to arrival. Those competitors who are approved for an official charter boat will be assigned a boat at registration on Sunday, August 1, starting at 1000. Representatives from LaserPerformance will be on site. You will be expected to help prepare and rig boats, with assistance from the LaserPerformance representatives. If your damage deposit form is not on file, you will not receive a boat.

• Please note section 7 of the Notice of Race regarding charter boat handling and damage deposits.

#### MEALS:

• Meals for each competitor will be provided at no additional cost. Breakfast will be at CBYC each day. Lunches will be provided each day. Dinners will be at CBYC or otherwise noted.

*Meals will only be available for non-competitors when advance reservations are made at registration.* Dinner tickets may be purchased for Sunday, Monday, and Tuesday for \$20 per dinner or \$55 for all three dinners. Dinner tickets for non-competitors can be purchased during on-site registration or as part of online registration. Breakfasts and lunches for noncompetitors will not be provided.

- Private coaches may purchase a meal plan as part of online registration for \$150 which includes; breakfast, lunch, and dinner during the regatta.
- <u>GUEST CARDS</u>: CBYC guest cards may be arranged through the on-site registration in Suite 102 for non-event dining or drinking at the club.

#### **HOUSING:**

- <u>Housing is NOT guaranteed</u>. CBYC has 50 beds available and will do its best to find more if they are needed. If you are interested in housing, you will need to submit the Housing Request form by May 15<sup>th</sup>. All requests will be reviewed at that time and you will be promptly notified. Late requests may not be honored if space is not available. Preference will be given to sailors 16 and under and distance will also be considered.
- <u>All non-local competitors, who are accepted for housing</u>, will be assigned a host family who will house you (the competitor) during the entire event. If you have someone you'd like to be housed with or have any particular requests or special circumstances, note this on the registration form. We will attempt to house skippers and crews together as best we can but we do separate by gender.
- If you are local and/or accompanied by a parent or other adult taking responsibility, your parent or guardian must sign the Alternative Housing Consent Forms, prior to registration, pledging to take full responsibility for you during the event, and stating that the adult taking this responsibility for you will comply with the curfew and all other rules concerning this Championship. There will be no exceptions. The Alternate Housing Consent Forms are included in this packet if you choose to make your own arrangements. The responsible adult must be present at registration. If the person designated as the responsible adult is not present, you will be housed elsewhere no exceptions.
- No Event housing will be provided to competitors after Wednesday, August 4, unless requested and approved by Shannon Bush in advance.
- <u>BEING A GOOD GUEST IN YOUR ASSIGNED HOUSING</u>: Housing will be generously provided by local families in their homes. It is a nice gesture to bring a small present to your host or hostess to thank them for their hospitality.

 Please be as easy a house guest as you can and show them that you appreciate their giving you a place to stay by not taking it for granted. When you arrive, call your parents with your host's name and phone number, and give your parents' names and number(s) to your host. Also, tell your host what your schedule is going to be so they know where you are at all times. Work out with your host where to hang your wet clothes, how "raidable" their refrigerator is, etc. It's easy.....just be considerate!

## **ALTERNATE HOUSING:**

• CBYC has arranged a rate of \$139.00 per night at the Doubletree Hotel, just down the street from the club for sailors traveling with parents or coaches. This is the most convenient hotel to the regatta and is also the only hotel within safe walking distance. Be sure to let them know that you are part of the U.S. Youth Championship.

### **MEDICAL FORM:**

Each competitor must send in a completed Medical Form to CBYC. If any medical issues change after that date, it is the responsibility of the parent/ competitor to notify the CBYC Regatta Registration Chairmen by e-mail.

### **EVENT BEHAVIOR:**

This Event is a "NO TOLERANCE" event; the use of alcohol or any illegal drug by a competitor will not be allowed or tolerated during the event. Offenders will be dealt with as stated in the Notice of Race.

### CURFEW:

- There will be a 2200 curfew during the event, meaning that ALL competitors must be "home" where they are being housed by 2200 each night.
- Host families will pick up their competitors no later than 2200 from the evening's social affair location. Be prepared to leave promptly.
- These regulations are in effect from Sunday, August 1 through Wednesday, August 4.
- There will be no exceptions, even for the sailors staying in their own homes or in privately arranged housing. We are not trying to make the event less fun; we are very concerned for your safety.

# TREATING THE HOST CLUB CORRECTLY:

CBYC has been planning and working on this event for a year. You can be assured that they want to put on the best possible event for you, from the racing, to the meals, to the social events, and to the housing. They take their regatta hosting very seriously, and as their guests you have an obligation to show that you appreciate their work through your actions. Whenever 120+ competitors descend on one club at the same time, the *possibility* is always there that the

place will be left a mess, stuff will turn up missing, club property will get damaged, and members will be inconvenienced. The future of the event depends on people wanting to host and run it, and most people don't want to associate themselves with an unappreciative group of teenagers. Remember that you have been *selected* to attend and that this is a privilege. Please be as self-sufficient as possible and help others as they need it. We expect that you'll jump in and help without being asked or forced to do so.

## PERSONAL SAILBOAT NOTIFICATION - e-mail by May 15:

Competitors who bring their own sailboats are required to send an e-mail to the CBYC Registration Chairman, (cortney@cbyc.org), entitled "Personal Sailboat Notification" by May 15 with your name and boat type. Boat trailer parking space will be assigned and provided at Registration.

# PRIVATE SPECTATOR / COACH BOAT NOTIFICATION – e-mail by May 15:

All spectator and coache boats are required to meet the conditions outline in US SAILING's Championships Support Vessels policy. This can be found at http://championships.ussailing.org/Youth/US\_Youth\_Champs.htm. Individuals who are unable to qualify are welcome to board the designated spectator boats.

- Private Coaches are required to register no later than June 15 online at http://championships.ussailing.org/Youth/US\_Youth\_Champs.htm.
- Send an e-mail to the CBYC Registration Chairman, (cortney@cbyc.org) entitled "Private Spectator / Coach Boat Notification" by May 15 with your name, associated competitor's name, boat type and length.
- Boat launch and trailer storage are available at CBYC dry storage areas. For your assigned trailer parking space and boat's mooring, check-in at Registration.

# SPECTATOR BOAT REQUEST - e-mail by June 15:

It is our intent to try to provide spectator boats for those wishing to go on the water.

- Spectators must send an e-note to the CBYC Registration Chairman, (cortney@cbyc.org) entitled "Spectator Boat Request" by June 15 with your name(s) and associated competitor's name.
- Sign up for each day will be at Registration in Suite 102.
- Spectators will be expected to make reservations and purchase lunches and beverages. No alcohol will be allowed on the spectator boats, as this is a NO TOLERANCE event. Please bring your own personal flotation device.

### PARKING:

Competitors with vehicles are allowed to use the parking lots located adjacent to CBYC. You do not need to notify CBYC in advance.

# LOCAL WEATHER:

• The Port of Los Angles area temperature can range between 70-80's, with water temperatures in the low to mid 60s. Please bring appropriate gear for these conditions. Wetsuits or drysuits are optional, but may not be necessary.

#### **MESSAGE CENTER:**

People wishing to leave messages for competitors may do so by posting on the message board in Suite 102 or by using the Facebook Page for the U.S. Youth Sailing Championships. Where possible, messages for the competitor will be left on the bulletin board at Registration.

#### PERSONAL GEAR:

- Mark your belongings in advance! Take a few minutes with a permanent marker and put your name on everything you will be bringing. Also, clearly label or otherwise mark your spars and other boat equipment. Remember that all Laser spars look identical and there will be nearly 50 sets of them lying around. A clearly marked piece of equipment is much less likely to "disappear."
- BRING THE FOLLOWING:
  - 1. Personal Flotation Device (Life Jacket) US Coast Guard Approved Type III or V PFD, Inherently Bouyant (i.e. not inflatable) <u>no exceptions</u>
  - 2. Water bottle
  - 3. Sunscreen, sunglasses and hat
  - 4. Tools and parts
  - 5. 30-foot tow line (required for all boats)
  - 6. Entertainment (e.g., frisbee, football, iPod)
  - 7. Appropriate gear for the conditions (sunshirt, spray top, and wet suit)
  - 8. Appropriate clothing (yacht club dining) for meals. Shoes and shirts required. No cutoff shorts, tank tops, or halter tops allowed in CBYC.

#### SAILING INSTRUCTIONS:

Sailing Instructions will be distributed at registration and will be available on the Youth Championship Event web page.

#### **GUESTS/ACCOMMODATIONS:**

Should you wish to bring guests (parents, coaches, etc.), be aware that we cannot be responsible for the housing, feeding or transportation of your guests. Guest Cards are required for purchase of meals at CBYC. (See Meals above)
