# SAILING INSTRUCTIONS

'[DP]' means that rule may be subject to a discretionary penalty. '[NP]' means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1 (<u>Right to</u> <u>Protest</u>).

In the event of any conflict between the NOR and the SI, the SI will prevail.

# 1. RULES

RRS 60.4 (a) (2) is changed as follows: "if it alleges a breach of a rule of Part 2 or RRS 31 and is from a boat that was not involved in and did not see the incident, or."

# 2. CHANGES TO SAILING INSTRUCTIONS

- 2.1. Any change to the schedule will be posted, at least 24 hours prior to the first scheduled warning signal, on the event's Regatta Network notice board at <u>https://www.regattanetwork.com/event/29033</u>.
- 2.2. Changes to a sailing instruction, excluding the schedule of the race, may either be posted on the event's Regatta Network Notice Board prior to 0900 on July 11 or may be made on the water by the race committee on the boat prior to the warning signal and after displaying signal flag "L" and a radio announcement by the race committee on VHF CH 72.

# 3. COMMUNICATIONS WITH COMPETITORS

- **3.1.** On the water, the race committee intends to monitor and may communicate with competitors on VHF radio CH 72
- **3.2.** The race committee may, but is not obligated to, communicate intended timing of warning signals and sail numbers of recalled boats on VHF CH 72.

# 4. CODE OF CONDUCT

See Notice of Race.

# 5. SIGNALS MADE ASHORE

- **5.1.** Signals made ashore will be displayed from the BYC flagpole.
- **5.2.** Flag AP displayed ashore means '1 minute is replaced with not less than 60 minutes' in Race Signals AP.

## 6. CLASS SIGNALS AND FLAGS

Boats shall display their class flag (numeral pennant) from their backstays while racing.

Class	Signal	Flag
Spinnaker	Numeral pennant 1	
Non-Spinnaker	Numeral pennant 2	
Double-handed Spinnaker and Non- Spinnaker	Numeral pennant 3	

## 7. RACING AREA

- 7.1. The racing area will include Buzzards Bay and Vineyard Sound.
- **7.2.** The start will be in the vicinity of Sippican Harbor Lighted Red Buoy "2" (F1 R) at Centerboard Shoal (BYC mark "G", approximate coordinates Lat N41 39.70, Long W70 43.60).

## 8. COURSES

Courses are as described in the Notice of Race.

# 9. STARTING

- **9.1.** Races will be started using RRS 26, with classes starting in the order in which their class signals are displayed on the course board. The scheduled time of the first warning signal is 1230 Saturday, July 12, 2025.
- **9.2.** The race committee may call attention to an unscheduled warning signal by making repetitive sound signals prior to the warning signal.
- **9.3.** The starting line will be between the staff from which an orange flag is displayed on the signal boat and the course side of the nearby mark.
- **9.4.** A keep-away buoy may be deployed off the stern of the race Committee boat.
- **9.5.** [DP] Boats whose warning signal has not been made shall avoid the starting area during the starting sequence of other boats.
- **9.6.** Any boat that does not start within 10 minutes after her starting signal will be scored Did Not Start (DNS) without a hearing. This changes RRS A5.1 and A5.2.

### **10. FINISHING**

- 10.1. The finish will be at Sippican Harbor Lighted Red Buoy "2" (F1 R) at Centerboard Shoal (BYC mark "G", approximate coordinates Lat N41 39.70, Long W70 43.60) leaving mark to port. There will not be a race committee finish boat on station; boats are responsible for taking their own finish times.
- 10.2. The navigator of a boat finishing shall record her finishing time (GPS time) when her mast is abeam of and within 25 feet of Sippican Harbor Lighted Red Buoy "2" (F1 R) at Centerboard Shoal (BYC mark "G", approximate coordinates Lat N41 39.70, Long W70 43.60). This time shall be

texted to the BYC scorer at 508-944-3157 not later than 0930 on Sunday, July 13, 2025.

#### **11. PENALTIES**

- **11.1.** RRS Appendix V (<u>Alternative Penalties</u>) will apply in its entirety.
- **11.2.** All post-race penalties must be taken before 1700 on the following Sunday regardless of whether a protest was filed. This changes RRS V2(a) (<u>Post-Race Penalties</u>).

### **12. TIME LIMITS**

The Tower Race has a time limit of 20 hours for each class.

### 13. PROTESTS AND REQUESTS FOR REDRESS

- 13.1. Protests and requests for redress shall be written on hearing request forms available online via the US Sailing Protest Form in the Race Information & Documentation section on the BYC website at <a href="https://beverlyyachtclub.org/racing">https://beverlyyachtclub.org/racing</a> or are available in the BYC Protest Box located on the wall to the left of the Clubhouse door on the porch. Scanned photographs of completed paper forms shall be emailed to <a href="mailto:protest@beverlyyachtclub.org">protest@beverlyyachtclub.org</a> within three hours from the time of the protesting boat's recorded finish (the protest limit).
- **13.2.** The Protest Committee will hear protests properly filed for the Parker Converse Tower Race starting at 17:00 on Sunday July 13 at Beverly Yacht Club. Competitors who may be parties to a hearing will be notified by 10 am on Sunday July 13.

### 14. HANDICAPPING AND SCORING

- **14.1.** The course distance is 48.3 nm.
- **14.2.** Each boat's finish position will be calculated using their PHRF rating and Time on Distance (TOD) scoring.
- **14.3.** Scores will be posted on the Parker Converse Tower Race site on Regatta Network at <u>https://www.regattanetwork.com/event/29033</u>.

### 15. PRIZES

Prizes will be awarded at Cups and Flags at BYC on October 4, 2025.

### 16. SAFETY

- **16.1.** When Code Flag "L" is displayed on the Race Committee signal boat before a warning signal, boats shall check in by sailing past the signal boat on starboard tack and hailing their numbers until acknowledged by the Race Committee.
- **16.2.** A boat that retires from racing shall notify the BYC scorer by texting 508-944-3157 at the first reasonable opportunity.

### 17. RISK STATEMENT

RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue racing is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia, or other causes. The Organizing Authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with, or prior to, during, or after racing.
