Notice Of Race (NoR) Amendment 1
The Organizing Authority (OA) for this regatta is the Venice Youth Boating Association
("VYBA"). The event will be held at the Venice Yacht Club ("VYC").

1. Rules

- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing* (RRS) 2025-2028
- 1.2 No Competitor shall use, either on or off the water, alcoholic beverages (beer, wine or distilled spirits), nicotine products, or use any controlled substance (marijuana, cocaine, etc.) the possession of which is unlawful. This prohibition is in effect during the entire event from date and time of arrival through date and time of departure from the venue. Penalties for a violation of the prohibition may range from a reprimand to dismissal from the regatta. A hearing may be held in accordance with the RRS.

2. Eligibility and Entry

- 2.1 This regatta is open to the following classes: Green Fleet, RWB Optimist, Club 420, HS 420, ILCA 4, 6, 7
- 2.2 Registration may be completed online at: www.regattanetwork.com/event/29216

- 2.3 Registration fees for single-handers is \$60, double-handers is \$120
- 2.4 After April 7 a \$15 late fee will be assessed
- 2.5 Entry deadline is midnight April 18
- 2.6 Registration fee includes a light breakfast, lunch for competitors, regatta shirt and SWAG bag. Lunch can be picked up in the VYBA Sailing Center in the morning!
- 2.7 We cannot accommodate special dietary requirements.

5. Venue

- 5.1 Racing will be conducted on Roberts Bay, adjacent to the VYC, for all optimist fleets and the Gulf for 420 and ILCA fleets.
- 5.2 NoR Addendum 1 shows the layout of the venue at VYBA, VYC and Higel Marine Park
- 5.3 Tarpon Center drive will have road construction; Please be patient as we work through the traffic and construction congestion.
- 6. Coach and Support Boats

⁻Awards ceremony to immediately follow completion of races

- 6.1 Coach and support boats will launch from Higel Marine Park and utilize the transient docks. **Trailers only** will be dropped and stored for the day at Higel Marine Park. All vehicles will be directed to designated vehicle parking lots.
- 6.2 Coach boats are required to register in regatta network at: https://veniceyouthboating.com/event-6036582
- 6.3 Parking is limited at the VYC and can only accommodate VYC employees; Additional parking at Graser park (located at the intersection of The Esplanade and Barcelona Ave; 746 Barcelona Ave Venice, FL 34285) and nearby public lots. We will provide a golf cart service from Graser Park to the VYC and back.

7. Spectator Boats

- 7.1 Spectator boats need to launch from the Venice Train Depot off Venice Island with cars and trailers stored there.
- 7.2 Please see Addendum 2 for directions and details
- 8. Prizes

Prizes will be awarded for 1st, 2nd, & 3rd in each fleet with a 1st in individual RWB. 1st – 5th place awards for Green fleet along with participation medals for all.

9. Safety

- 9.1 Competitors shall always wear U.S. Coast Guard approved life jackets (except briefly while adjusting clothing). Failure to do so will result in disqualification.
- 9.2 Persons operating power vessels in the regatta area shall always wear U.S. Coast Guard approved life jackets (except briefly while adjusting clothing) and the safety kill switch lanyard (killcord). Failure to do so will result in ejection from the regatta area. All coach boats shall show the race committee on their course their engine shut off device.

10. Photography & Media Rights

Competitors give absolute right and permission for any photographs or video footage taken of them or their competing boat to be published in any media whatsoever; for editorial or advertising purposes, or to be used in press information. VYBA reserves the right to fly a drone during the racing events, however no footage

will be available to any coaches until after the full regatta events have ended. No other drones will be allowed in the sailing areas.

11. Disclaimer of Liability

Competitors participate in the regatta entirely at their own risk. The organizing Authority (VYBA), VYC, Sarasota County, and the city of Venice will not accept any liability for material damage, personal injury or death sustained in conjunction with, prior to, during, or after the regatta.

RRS 3 states: 'The responsibility for a boats decision to participate in a race is hers alone.'
