Sailing Instructions

South Coast Corinthian Yacht Club invites all dinghies to the now annual Shallow Water Series. A four-event series throughout the year, comprised of one to five races per event.

GENERAL INFORMATION

1. RULES

- 1.1 This series will be governed by the rules as defined in the 2025-2028 Racing Rules of Sailing (RRS).
- 1.2 Each entrant must meet the eligibility, entry and fee requirements as outlined in the Notice of Race.
- 1.3 Competitors shall not intentionally discharge waste material into the waters of Marina del Rey Harbor.
- 1.4 Alternative penalty appendix V1: One-turn penalty while racing but Two-turn penalty while in the zone around a mark other than the starting mark.

2. NOTICE TO COMPETITORS

- 2.1 The Race Committee (RC) may make verbal notices while on the water.

3. CHANGES TO SAILING INSTRUCTIONS

- 3.1 Any change to the sailing instructions will be posted before 1100 on the day of race.

4. SCHEDULE OF RACES

Three or more races will be scheduled. The RC may, at its discretion, run fewer or more races.

The first Start at 1300 hours, RC will attempt to complete racing by 1530 hours.

5. CLASS FLAGS

- 5.1. This is a pursuit race, the Lido Class flag will be used to start the first boat(s)

6. RACING AREA

- 6.1. Racing will be inside Marina del Rey Harbor turning channel. The "Course Chart" shows the location of the racing area.

7. THE COURSE

- 7.1. See the Shallow Water #3 Course Chart.

8. Check In

- 8.1. Boats are required to check in with the race committee. The number boats coming to the starting area is used to calculate results.

- 11.1 The finishing line will be the same as the starting line.

12. PROTESTS

12.1 Protests are encouraged to be filed with the race committee.

12.2 Protests will be heard as soon as possible, possibly at the dinghy dock. However, at the discretion of the RC, protests may be heard at another date convenient to all parties.
