1. RULES

1.1. The event is governed by the rules as defined in The Racing Rules of Sailing.

1.1.1. RSS 52 is modified to allow the use of autopilot for double and single-handed racers only.

1.1.2. RSS 52 is modified to allow the use of powered winches.

1.1.3. RSS 63.1, prescriptions are not in effect.

2. COMMUNICATION WITH COMPETITORS

2.1. Notices to competitors will be posted on the official notice board located at Hawaii Yacht Club.

3. SCHEDULE OF RACES

3.1. Saturday, October 4th.

3.1.1. First Start - 10:00:00 am

4. COURSE

4.1. Start – Oahu (P or S) - Finish

4.1.1. Stay to seaward of all government navigational buoys and the restricted area near Barbers Point.

4.1.2. Moku Manu is not a mark on the course.

5. THE START

5.1. The start is 100 yards to seaward of R2 of the Ala Wai Channel in line with the cement channel markers.

6. THE FINISH

6.1. The finish is 100 yards to seaward of R2 of the Ala Wai Channel in line with the cement channel markers.

6.2. Record your finish time and report it to Race Committee. Text is preferred.

7. PROTESTS AND REQUESTS FOR REDRESS

- 7.1. Protest forms are available from the race committee or on the HYC official bulletin board. Protests and requests for redress shall be delivered to the race committee within the appropriate time limit.
- 7.2. The protest time limit is 90 minutes after the last boat in the race has finished.
- 7.3. Notices of protests by the race committee or the protest committee will be posted to inform boats under RRS 61.1(b).

8. SCORING

- 8.1. Staggered start times were calculated using Time on Distance. The distance of the course was estimated at 102nm.

9. SAFETY REGULATIONS

- 9.1. VHF Channel 68 is reserved for essential communications, otherwise yachts shall monitor VHF Channel 16.
- 9.2. Upon withdrawing from the race, yachts shall inform the race committee via text message (808-312-2249). Failure to do so may result in denied entry to future races.

10. PRIZES

- 10.1. For each class, 1st prize will be awarded if three or more boats enter, 2nd prize will be awarded if five or more boats enter, and 3rd prize will be awarded if seven or more boats enter.

11. DISCLAIMER OF LIABILITY

- 11.1. Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the race.

12. INSURANCE

- 12.1. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$500,000 per event or the equivalent.
