## Notice of Race

**Monday, September 7<sup>th</sup>, 2026**

**Organizing Authority Hawaii Yacht Club**

**1. RULES**

- A. The race shall be governed by the rules as defined in The Racing Rules of Sailing 2025-2028, including US Sailing Prescriptions, unless otherwise amended in this Notice of Race or the Sailing Instructions.

**2. ADVERTISING**

- A. Advertising shall comply with ISAF Regulation 20. Competitor advertising will not be restricted.

**3. ELIGIBILITY AND ENTRY**

- A. The regatta is open to all yachts that meet requirements for ISAF Offshore Special Regulations Category 3 (no liferaft required).
- B. The regatta is open to all yachts that are members of HYRA member clubs, and other yachts that may be invited by the organizing authorities.
- C. Eligible yachts may enter via the US Sailing Regatta Network website. Entries will only be accepted using the Regatta Network website.
- D. Entry deadline 11:59pm, Wednesday September 2, 2026 for regular entry fee. No entries will be accepted after Friday September 4, 2026

**4. MOORING**

- A. Mooring/anchorage in Ka'anapali is available on a first-come, first serve basis. The Lahaina Small Boat Harbor is absolutely off limits and no shore services are available. The Harbor Agents can be reached at 808-662-4060. The LYC office can be reached at 808-661-0191.
- B. Mooring in Waikiki after the regatta is available on a first come first serve basis. Temporary moorings may be available at the Ala Wai Harbor or at the HYC Aloha Dock. The Ala Wai Harbor Master can be reached at 808-973-9727. Contact HYC Port Captain for moorage at Hawaii Yacht Club.

### 7. MEASUREMENTS

- A. Each boat racing in PHRF Class X, A, or B, shall have a valid YRA / NCPHRF Northern California Performance Handicap Racing Fleet handicap certificate valid for 2025 or 2026. No exceptions, except for a new boat entering the fleet. Cruising class boats can have an assigned rating based on the NCPHRF Base rating. The NCPHRF certificate application can be found at [WWW.YRA.org](http://WWW.YRA.org).

### 8. SAILING INSTRUCTIONS

- A. Sailing instructions will be available on Regatta Network.

### 9. VENUE/COURSE

- A. The course will be a race from Ka'anapali, Maui to Ala Wai Boat Harbor, Oahu.

### 10. SCORING

- A. Corrected times will be calculated using the PHRF Time-on-Time scoring system, as adopted by HYRA.
- B. The low point system of RRS Appendix A shall apply without modification.

### **11. PRIZES**

- A. For each class a first prize will be awarded if at least three boats enter, second prize will be awarded if at least five boats enter, and third prize will be awarded if at least seven boats enter.

### **12. DISCLAIMER OF LIABILITY**

- A. The responsibility for a boat's decision to participate in a race or the continue racing is hers alone. See RRS Rule 4, Decision to Race. The organizing authority will not accept liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

### **13. INSURANCE**

- A. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$500,000 per event or the equivalent.
