NOTICE OF RACE

GENERAL INFORMATION

1. RULES

1.1 The event is governed by the rules as defined in [The Racing Rules of Sailing](#) (RRS).

2. SAILING INSTRUCTIONS

2.1 The respective series Sailing Instructions (SIs) will be posted by 2000 on the Sunday prior to the respective series start on the official notice board.

3. COMMUNICATION

3.1 The Official Notice Board is the [series page on Regatta Network](#), a link to which can also be found on the [Marina del Rey Venture MacGregor Fleet](#) website (www.mdrvrmf.com).

3.2 [DP] All boats shall carry a VHF radio capable of communicating on normal domestic channels.

3.3 On the water, the RC may make courtesy broadcasts to competitors on VHF radio, including starting penalties. The channel will be stated in the SIs.

4. ELIGIBILITY AND ENTRY

4.1 Event is open to all boat types.

4.2 To be considered an entry for the series, a skipper shall complete the registration and series payment requirements.

4.3 Boats possessing a current PHRF SoCal certificate should provide their 2026 rating as requested. If un-rated, a rating will be assigned.

4.4 To participate in the March warm-up races, registration and payment must be made prior to the start of those races.

4.5 Competitors who participate without registration and payment will not be scored.

5. CLASSES

5.1 Classes will be divided based on PHRF rating.

5.2 One design boats with 5 or more entries will be provided their own scoring class.

5.3 Class breakdown, relevant for all series, will be posted in each series SI no later than Sunday prior to the series start on the official notice board.

6. FEES

- 6.1 A one-time payment of \$100 at time of registration will cover a skipper's MDRV MF membership and series race fee.
- 6.2 Skippers can join the season at any time by paying fee and registering on Regatta Network. Skippers that join after July 13th will pay a discounted series and membership fee of \$50.
- 6.3 All crew members are welcome to join MDRV MF as a member to obtain discounts at US Sailing as well as a discounted rate for the end of season party. Single crew memberships can be purchased by contacting the Commodore.

8. VENUE

The racing area will be inside Marina del Rey marina and in Santa Monica Bay.

9. COURSES

The course descriptions will be posted in the SI for each series on the [Official Notice Board](#) no later than the Sunday prior to the start of each series.

10. PENALTY SYSTEM

- 10.1 US Sailing Prescription Appendix V, Section V1 (Penalty at the Time of an Incident) applies.
- 10.2 For all classes, RRS44.1 is changed so that the two-turn penalty is replaced by the one-turn penalty.

11. SCORING

- 11.1 Races will be scored using PHRF SoCal Area B ratings using Time on Time scoring method. Boats without a rating will be assigned one based on other SoCal area ratings and suggested manufacturer ratings.
- 11.2 Only one rating can be used in each category for the entire series. Boats with multiple ratings must choose a single rating to use for entire series.
- 11.3 Series races will be automatically scored with spinnaker ratings. A boat that does not have a spinnaker must enter their non-spinnaker rating for all races. Ratings will not be changed once the overall series begins.

12. PRIZES

- 12.1 Awards will not be presented for warm-up races.
- 12.2 Awards will be presented to the 1st and 2nd place winners in each class per series as well as overall.
- 12.3 A perpetual trophy will be presented.
- 12.4 Awards will be presented at the end of season party.

13. HOSPITALITY

- 13.1 Post-race hospitality will take place at Santa Monica Windjammers Yacht Club (SMWYC) located at 13589 Mindanao Way, Marina del Rey, CA 90292
- 13.2 Non-hosted food and refreshments will be available following the race.
- 13.3 End of season party date and location to be announced on/about October 20, 2025.

14. RISK STATEMENT

Competitors in the event are participating entirely at their own risk. See RRS 3, Decision to Race. By participating in the event, each competitor agrees to release the race organizers (organizing authority, race committee, protest committee, sponsors, and any others acting in an official capacity for the event) from any and all liability associated with such competitor's participation in the event to the fullest extent permitted by law.
