

# 2010 Soling U.S. Championship

## Notice Of Race

Severn Sailing Association  
Annapolis, Maryland  
October 22-24, 2009

### 1 **Organizing Authority**

The Organizing Authority is the Severn Sailing Association in Cooperation with the United States Soling Association (USSA) and the Chesapeake Soling Fleet .

### 2 **Rules**

The event will be governed by the Racing Rules of Sailing (RRS) 2009-2012, and the International Soling Association (ISA) Championship Rules. This Notice of Race will rule except as amended or altered by the Sailing Instructions, or properly posted amendments on the Official Notice Board. All racing will be fleet racing.

### 3 **Advertising**

The Championship will be a category C event under ISAF Regulation 20.

### 4 **Eligibility**

4.1 The regatta is open to all yachts declared eligible by the USSA, CISA or their national Soling association. All skippers and crew must be 2010 members of the USSA, CISA, or the ISA. US skippers shall be members of the United States Sailing Association. Canadian entrants shall be members of the CISA. Proof of membership shall be required for on-line registration or demonstrated at on-site registration.

4.2 It is also required that all yachts entering the regatta display the ISA sticker for the current year.

### 5 **Registration/Entry Fee**

5.1 The entry fee is \$95 US per boat, payable at registration.

5.2 Registration and USSA membership application may be accomplished online at: ([need regattanetworks link](#))

5.3 The entry fee includes trophies, post race beer and snacks each day, as well as oysters (if available – if not alternative treats will be provided) after Friday racing for all competitors, SSA and USSA registration fees, launching and trailer storage during the event.

5.4 Dinner on Saturday evening will be available at reasonable prices and reservations can be made via email to [realfoodSSA@gmail.com](mailto:realfoodSSA@gmail.com), or can be reserved via the online registration.

5.5 Event apparel can be ordered via the online registration link.

### 6 **Schedule of Events**

6.1 On-site registration will be at the Severn Sailing Association (SSA) on Thursday, October 21 from 1500-1700 and Friday, October 22 from 0800-0930.

6.2 Competitor's meeting will be held at 0930 on Saturday, October 22, 2010.

6.3 Fleet Racing:

2 races Friday, October 22, warning signal at 1100;

Oysters/Beer/Snacks at SSA, October 22 immediately after racing;

3 races Saturday October 23, warning signal at 1030;

Beer/Snacks, October 23 immediately after racing;

Dinner at SSA, Saturday October 23 at 1800;

2 races Sunday October 24, warning signal at 1030;

No warning signals shall be given after 1400 on Sunday October 24.

**7 Measurement and Safety**

Regatta Officials reserve the right to measure and/or stamp all sails and ask each yacht to submit a valid measurement certificate. Random inspections for class safety rules may be conducted at any time during the regatta.

**8 Liability**

The organizing authorities and/or any part, person involved in the regatta, will accept no liability and responsibility for any personal or material damage sustained prior to, during, or after the regatta.

**9 Sailing Instructions**

The Sailing Instructions shall be available at registration.

**10 Regatta Site**

The regatta site is the Severn Sailing Association, 311 First St., Annapolis MD. Telephone (410) 268-8744. Directions to Severn Sailing Association are available at the club website: [www.severnsailing.org](http://www.severnsailing.org).

**11 Racing Areas**

The racing area shall be ESE of the mouth of the Severn River, in the Chesapeake Bay, as indicated on attachments to the Sailing Instructions.

**12 Courses**

The courses will be triangular or windward-leeward as shown in the sailing instructions.

**13 Scoring**

The low point scoring system, RRS Appendix A2 scoring system will apply. There are seven races scheduled. Four races completed shall constitute a regatta. If five races are completed, each boat's series score will be the total of her race scores excluding her worst when prohibited by Rules A1-3.

**14 Penalties**

RRS Rule 44 applies.

**15 Prizes**

Prizes will be awarded to each member of the crews placing first, second and third in the regatta.

**16 Insurance**

Each participating boat shall have adequate insurance cover, specifically including third party liability cover while racing of at least US\$300,000 for the duration of the regatta.
