1. RULES

- 1.1 The regatta will be governed by the Racing Rules of Sailing (RRS), except as any of these are altered by this Notice of Race and/or by the Sailing Instructions.
- 1.2 The Rules of the International Optimist Dinghy Association, the Rules of the International Laser Class Association and the Rules of the Snipe Class International Racing Association (SCIRA) will apply, except as any of these are changed by these Notice of Race and/or by the Sailing Instructions.
- 1.3 English shall be the official language for the Race.

2. ELIGIBILITY AND ENTRY

- 2.1 All registrants must be a current member of the class association (RRS75.2 Competitors shall comply with ISAF Regulation 19, Eligibility Code).
- 2.2 If you are not a current member of the class association, membership to the association will be available for a nominal fee.

Competitors are to be acquainted with ISAF RRS Part 1 Fundamental Rule 4: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone". In any case, competitors agree that the Club Nautico de San Juan, the sponsors and their agents, have no responsibility for loss of life or injury to members or others or for the loss of, or damage to any vessel or property. As part of the registration process, each individual participating crewmember will be required to sign a declaration accepting this disclaimer of liability.
