COLUMBUS DAY REGATTA 2011

Organizing Authority: Columbus Day Regatta, Inc.

1. Rules

The regatta will be governed by the rules as defined in the current Racing Rules of Sailing.

2. Eligibility

The regatta is open to boats of the following classes:

PHRF CLASS: Current PHRF certificate. If the certificate is not from Southeast Florida PHRF, it may be subject to adjustment by the Columbus Day Regatta Ratings Committee.

ONE DESIGN: To be determined by Committee. **NOTE:** All Yachts currently racing PHRF or One Design shall be entered in those fleets. Entries submitted without certificates will not be accepted.

ASSIGNED RATING CLASS: Any boat with present or past racing ability, 18' or larger LOA, will have a rating assigned by the Committee and must use the sails declared by the Master on the entry form. Picture and manufacturer specifications must accompany application form. Yachts intending to use two genoas downwind must declare them on the entry form.

MULTIHULL: Permanent cruising accommodations – Catamarans or Trimarans, 24' or larger, using MASF rating.

BEACH CATS: Open to catamarans 14' or larger and scored on the Portsmouth handicap system.

GUNKHOLE CLASS: Cruising pleasure yachts, as selected by the Committee, will have a rating assigned by the Committee. Picture and manufacturer specifications must accompany application form. Spinnakers, bloopers, or specialized sails will not be allowed. (Specialized sails are any sail flown free and not hanked on).

3. Entry

Competitors may register by completing the online entry form found at www.columbusdayregatta.net and paying the entry fee. Entries without boat ratings must supply a picture and manufacturer specifications along with a copy of their entry to Columbus Day Regatta, c/o Coral Reef Yacht Club, 2484 S. Bayshore Dr, Miami, Florida 33133; or contact the CDR Chairman at 305-915-1438. **The DEADLINE for entering shall be Tuesday, October 4, 2011.** Positively no entries will be accepted after that date.

4. Fees

\$75.00 entrance fee for yachts registering by Sunday, September 25, 2011. Entries received after that date will be **\$95.00 until Saturday, October 1, 2011 and will be \$125.00 after that.** No entries will be accepted after **October 4, 2011.** A \$5.00 reduction for USSA members with copy of membership card. **\$10.00 reduction for first time Masters.**

5. Schedule

There will be a **SKIPPER'S MEETING** at Coral Reef Yacht Club on Friday, October 7, 2011 at 1900 hours. The Regatta shall consist of one race each day with the warning for the start of the first class at 0955 hours, Saturday, October 8, 2011, and at 1055 hours, Sunday, October 9, 2011.

6. Courses (as shown in the brochure)

Boats will start in the vicinity NE of Quickflash on Saturday and race down the bay to the finish in the vicinity N of Black Ledge. Sunday's race will start in the vicinity N of Black Ledge and race up the bay to the finish in the vicinity NE of Quickflash. An orange flag on the Race Committee Boat and a Red Bacardi inflatable mark will designate the start and finish lines.

7. Sailing Instructions

Final sailing instructions, starting times, course information, Columbus Day flag, class flag, scratch sheet and boat number will be included in the packet to be picked up and signed for by each master or his representative on October 6th and 7th at the following places and at the time indicated:
