J/22 Southwest Circuit, June 22-24

J-22 Circuit Regatta # 4

J/22 Southwest District, Oklahoma City Boat Club and J/22 Fleet #36 cordially invite you to attend the J-22 Circuit Regatta #4, a J/22 2012 Southwest Circuit Regatta to be held June 22, 2012 through June 24, 2012 in combination with OCBC's Lighthouse Charity Regatta. This is a five race Regatta with the option for a sixth race for J/22 Sailboats. This is the fourth Regatta in the J/22 Southwest Circuit.

Rules: The Regatta will be governed by the rules as defined by the 2009-2012 Racing Rules of Sailing (RRS) and is designated Category C as restricted by IJ22CA rule 2.9.8 (a). The same crew and the same three class sails must be used during the entire Regatta. Substitutions can only be made with the written approval of the Protest Committee or Chief Judge. Boats (including rudders) may not be removed from the water during the Regatta without the approval of the Protest Committee or Chief Judge. Boats must be in the water by noon on Saturday. Sailing instructions will be distributed at registration. Guidelines for the J-22 Southwest Circuit will be issued to the PRO and Chief Judge before the skippers meeting.

Eligibility: J/22 Class yachts in compliance with class rules will be scored. In accordance with the J/22 Southwest District Notice of Circuit, owners and helmsmen who are not class members, boats without a valid measurement certificate or whose teams exceed the crew weight limit of 275kg in Class rule 8.9 may participate and be scored in this Regatta, but their Regatta finish shall not be kept for purposes of scoring in the Southwest District Circuit.

Location: The Regatta will be held at Oklahoma City Boat Club on Lake Hefner in Oklahoma City, Oklahoma.

Fees: The entry fee is \$50.00 pre-registered before June 19, 2012 and \$60.00 at registration. To be eligible for pre-registration, a completed registration form must be sent by online registration before June 19, 2012. Online registration is available on the SW District website at www.j22southwest.org. All registration fees are payable prior to 9:00 AM on June 23, 2012. Entry fee includes

Friday evening: dinner ("free will" donation)

Saturday: complimentary breakfast & lunch

Dinner, Dancing & Entertainment @ \$20.00/person early reg. and @25.00/person after June 19, 2012

Scoring: Appendix A as modified by the Sailing Instructions. Five races are scheduled with an option for a sixth race of which one shall be completed to count as a Regatta for the Lighthouse Charity Regatta; however, two shall be completed for points to count towards the Southwest Circuit standings. No races will be discarded for the J/22 Southwest Circuit this changes Appendix A2.

Inspection & Measurements: All participants are subject to inspection and measurement at any time during the Regatta. The Race Committee may, at its discretion, inspect any yacht in order to confirm compliance with the prescribed class rules concerning construction

and measurements, safety rules when racing, crew prohibition and restrictions when racing. Class royalty tags must be present on all sails.

Appeal: Decisions of the Protest Committee with regard to protests, requests for redress and other actions by the Race Committee or Protest Committee shall be subject to appeal according to rule 70 of the RRS.
