

Sailing Instructions 2012 J-120/J-111 South Beach Invitational Regatta



June 30th & July 1st, 2012 South Beach Yacht Club

1. RULES

The regatta will be governed by the rules as defined in *The Racing Rules of Sailing for 2009 - 2012* (RRS). The J 120 Fleet will be sailing under J 120 Fleet Five rules. These J 120 rules include the following modification to the RRS; The first sentence of rule 44.1 is modified as follows: 'A boat may take a penalty when she may have broken a rule of Part 2 or rule 31 while racing. The penalty shall be a One-Turn Penalty unless she may have broken a rule of Part 2 while racing within the zone of a rounding or finishing mark, in which case the penalty shall be a Two-Turns Penalty. Starting marks are not rounding marks.'

1.1. All competitors are required to wear a life jacket or other adequate personal floatation device while racing. This changes RRS 40.

2. ENTRY FEES

- 2.1. Entry fees are as follows: \$90; \$125 if received after June 27th 2012.
- 2.2. Late registration will be held on-site on Saturday, June 30th between 0930 and 1030.

3. NOTICES TO COMPETITORS

- 3.1. Official notices will be posted on the Regatta Notice Board at South Beach Yacht Club.
- 3.2. Any changes in the Sailing Instructions will be posted by 1130 on the day they are to take effect.
- 3.3. Competitors should monitor VHF Channel 78 for on the water communications with the Race Committee.

4. SIGNALS MADE ASHORE

4.1. Signals made ashore will be displayed from the flagpole located on the deck of South Beach Yacht Club. If a postponement is signaled ashore, the warning signal will be made not less than 45 minutes after flag AP is lowered. This changes Race Signals AP.

5. SCHEDULE AND CLASS FLAGS

- 5.1. A Competitors meeting will be held on Saturday, June 30 at 1100 hours in the SBYC Clubhouse.
- 5.2. Prizes will be awarded to the top three finishers of the J/120 fleet and the First place finisher of the J-111 fleet after the racing on Sunday, July 1 in the South Beach Yacht Club Clubhouse between 30 minutes and one hour after the conclusion of the scoring of the Regatta.
- 5.3. Five races are scheduled in the series as follows (all courses will be Windward/Leeward courses):

4. RACING AREA

4.1. The race will be sailed in the South Bay Waters of San Francisco Bay located in the general area east of South Beach Harbor and around Anchorage 9.

5. THE COURSE

- 5.1. The marks, courses and rounding are described in Appendix "A", MARKS AND CHARTLET, COURSES AND ROUNDING ORDER. Code and course flag(s) will be displayed from a staff on the Race Committee boat.
- 5.2. All rounding marks are to be passed to Port, unless a Starboard rounding flag is flown from a staff on the Race Committee boat. Both windward (Mark W) and leeward (Mark L) rounding marks shall be an inflatable orange tetrahedron buoy. The windward offset mark (Mark O) shall be a small round orange mark that is roughly 2 feet in diameter, or an inflatable orange tetrahedron buoy.

6. THE START AND FINISH LINES

6.1. The start line and finish line shall be between an orange flag on the Race Committee Signal Boat and a large inflatable yellow round buoy (Mark S). The lines will be set to leeward of Mark L

7. TIME LIMITS

- 7.1. The time limit for each race is 3 hours.
- 7.2. A boat starting, but not finishing more than 20 minutes after the first boat to finish in any race will be scored DNF by the Race Committee. This changes RRS 35, A4 and A5.
- 7.3. A boat must start within five (5) minutes of the start signal for her to be scored in that race.

8. SCORING

8.1. Five (5) races are scheduled, of which one (1) must be completed to constitute a series.

9. PROTESTS

- 9.1. Protests and requests for redress shall be written on standard US SAILING Protest Forms. Protest Forms are available at South Beach Yacht Club from the Race Committee and shall be delivered to a Race Committee Representative within one hour after the Race Committee Boat returns to the dock. The Race Committee Boat's return time shall be posted on the Regatta Notice Board at South Beach Yacht Club.
- 9.2. The time and place of all protest hearing(s), the boat(s) being protested and boat(s) requesting redress shall be posted on the Regatta Notice Board at the South Beach Yacht Club within 30 minutes of the protest time limit. It is each boats responsibility to check the Regatta Notice Board to see if they are a party to a protest or redress hearing. This shall serve as proper notification per RRS 63.2.
- 9.3. Prior to a protest hearing the party who filed the protest may make a (binding) verbal request to Protest Committee Chairperson that the protest be withdrawn. Once a protest has been withdrawn, it cannot be reopened, appealed or redressed.

10. COMMERCIAL TRAFFIC AND/OR INTERFERENCE WITH OTHER VESSELS

- 10.1. Boats shall not impede the passage of commercial vessels and shall comply with USCG Navigation Rules. If a commercial vessel has sounded five blasts, and the commercial vessel or the Coast Guard identifies the boat, the Race Committee shall protest the boat, in which case the Protest Committee shall assume that the identified boat has impeded passage of violated USCG Navigation Rules, and the identified boat shall have the burden of proving otherwise. In the case of a complaint by vessel traffic or the Coast Guard, the protest time limit shall be extended up to seven (7) days after the conclusion of the Regatta. This changes RRS 60.2(a) and RRS 61.3.
- 10.2. The South Beach Yacht Club and the South Beach Yacht Club Race Committee shall cooperate with and provide information relevant to any investigations of impeding passage or violation of USCG Navigation Rules by the Coast Guard or other governmental authority.

11. DISCLAIMER OF LIABILITY

11.1. Boats and competitors compete in the Regatta entirely at their own risk. See RRS 4 – Decision to Race. The organizing authority, the South Beach Yacht Club, J-120 Fleet 5, the J111 Fleet and/or any of their collective agents or representatives will not accept any liability for material damage, personal injury or death sustained in conjunction with or prior to, during or after the Regatta.



Sailing Instructions APPENDIX A MARKS AND CHARTLET COURSES AND ROUNDING ORDER



Both windward (Mark W) and leeward (Mark L) rounding marks shall be an inflatable orange tetrahedron buoy. The windward offset mark (Mark O) shall be a small round orange buoy that is roughly 2 feet in diameter, or an inflatable orange tetrahedron buoy. The start line and finish line shall be between an orange flag on the Race Committee Signal Boat and an inflatable yellow round buoy (Mark S). The start and finish lines will be set to leeward of Mark L.
