WAIVER, RELEASE & INDEMNIFICATION

The Biloxi Yacht Club, the Gulf Yachting Association and all Sponsors and Suppliers of The GULF OCEAN RACING CIRCUIT, their officers, directors, members, committee personnel, volunteers, employees and agents are in no way to be held responsible for accidents, damage or injury to property or to yachts, crew or guests arising from any cause during or related to any activities of the GORC. Each Skipper/Owner and crew must evaluate weather and sea conditions and each participant is responsible for determining whether it is safe for him or her to participate. The responsibility of wearing a life jacket rests upon the Skipper/Owner and crew. If assistance is provided by Committee vessels and personnel, it is at the knowing and voluntary risk of the participants.

In consideration of your accepting my entry for the GULF OCEAN RACING CIRCUIT, I do for myself, my heirs, my executors, my administrators, my personal representatives and assigns, waive and release any and all claims that I have against the Biloxi Yacht Club, the Gulf Yachting Association and all Sponsors and Suppliers of GULF OCEAN RACING CIRCUIT, their officers, directors, members, committee personnel, volunteers, employees and agents, or any one or more of them or their executors, administrators, personal representatives, heirs, next of kin, successors, or assigns, including any or all claims for damage caused by the acts or omissions of any of them arising out of my participation or that of my yacht in the GORC and its related activities, including pre-start and post-finish operations and shore activities together with any costs and expenses including attorney's fees that may be incurred as a result of any such claim whether valid or not, and I do hereby agree to indemnify and hold harmless each of them against any such claims that any officer, member of my crew or one of my guests (or the executors, administrators, personal representatives, heirs, next of kin, and assigns of any of them) may have or assert together with any costs and expenses including attorney's fees with respect thereto.
