Dear 2013 U.S. Youth Championships Competitor and Parents,

On behalf of US Sailing, our host, the Corpus Christi Yacht Club (CCYC), and our sponsors, we congratulate you on your selection to the 2013 U.S. Youth Championships. We have been planning this event for some time with the hope that you will have a great sailing experience and a memorable stay in Corpus Christi, Texas. We are looking forward to your arrival in Corpus Christi on Monday, August 12th.

WEBSITE:

Information about the Regatta will be posted at Youth Championships website: <http://www.usyouthchamps.com/>. This website will include information about operations, the event site, and transportation.

TRAVEL INFORMATION:

CCYC is located at: 98 Cooper's Alley, Corpus Christi, TX 78401

Early arrivals at the club are not permitted – ***no exceptions***. Being "invited" by a CCYC member is *not* an exception to this rule.

Please do not arrive prior to registration opening. Arrival for all competitors will be from 1200-1830 on Monday, August 12. **Early arrivals at the site will not be permitted.**

Attendance at the Awards Ceremony on August 16 is **mandatory**. Departure from CCYC for all competitors will be after 1600 on Friday, August 16th unless other arrangements are made and approved **at least three weeks in advance** by the US Youth Champs National Chair (usyouthchamps@gmail.com). Exceptions will only be granted in unusual circumstances.

Violations will be dealt with strictly by the Organizing Committee and US Youth Champs National Chair, Malinda Crain, and may be passed to the protest Committee.

All boats and trailers should be removed from the venue by 2000 hours on Friday, August 16.

TRAVELING BY AIR:

[Corpus Christi International Airport](#) (CRP) is the airport competitors arriving by air will use. There is only one terminal and one baggage collection area, so it is easy to navigate. A greeter will meet arriving competitors in the baggage collection area.

Please plan your arrival at CRP between 1130 and 2000 on Monday, August 12. If your flight will arrive outside of these times, special arrangements will need to be made at your expense. Please contact the Registrar no later than August 1st.



Plan your departing flight to leave no earlier than 1700 on Friday, August 16. No event housing will be provided to competitors after the regatta finishes on Friday.

US Sailing has negotiated a discount code from United Airlines for travel to the 2013 Championships. To obtain this discount, book your tickets at www.united.com/usoc. Use Event code ZNZ2269260 in the electronic certificate or promotion code box. American Airlines and Southwest Airlines also serve CRP.

Competitors will need to make their way to the baggage claim area without an escort. Please advise your parents to make appropriate arrangements with the airlines if you are traveling as an unaccompanied minor. If you are traveling as an unaccompanied minor or are 15 years old or under, please be sure to bring a credit card to pay the separate 'unaccompanied minor fee' at check in for your return flight. There have been instances where sailors have flown out on their own, but not been allowed by the airlines to fly back on their own. We would rather you be over prepared than under prepared!

Ground transportation between CRP and Corpus Christi Yacht Club will be arranged for competitors and scheduled in accordance with flight departure and arrival times. The cost of travel from the Corpus Christi International Airport and CCYC will be \$10.00 each way. Please bring cash.

Ground transportation from other airports in Texas to CRP is **not** available.

FOR YOUR OWN SAFETY, DO NOT ACCEPT RIDES OR TRANSPORTATION to or from the Corpus Christi International Airport that have not been arranged through the 2013 Youth Champs Organizing Committee.

TRAVEL DELAYS OR QUESTIONS:

You must add your arrival and departure information to your Regatta Network registration module no later than Thursday, August 1st. Updates and changes may be made there at any point until the deadline. Any changes regarding transportation, airlines, or changes to your travel schedule after the deadline, should be directed to the Registrar on Regatta Network.

If there is a flight delay or problems with your itinerary on the day of travel, please call our Regatta Registrar, Mary Sterett (marysterett@aol.com) at 361-658-2716. Another number for day of travel emergency is Sandra Carl 361-537-3374 or lajoya@msn.com.



ON SITE CHECK-IN AND REGISTRATION:

Registration will be open on Monday, August 12th from 1200 – 1830 hours, and Tuesday August 13th from 0800 – 1000. Upon arrival at CCYC, proceed directly to registration where the registration team will confirm that all forms have been correctly submitted and you will be issued an event ID and wristband. Your life jacket will be inspected at registration. **Bring a USCG approved pfd.** Please refer to the NOR for requirements.

If you are not staying in private housing provided by the event, the adult responsible for you during the regatta must accompany you to registration.

Competitors will be expected to install the provided hull stickers, and the hull and/or sail numbers following registration. Competitors' sails must be numbered in accordance with class rules. A country code is not required.

MEDICAL FORM AND WAIVERS:

Each competitor must send a completed Medical Form along with all of the required waivers and forms to Regatta Registrar Mary Sterett, 3528 Aransas Street, Corpus Christi, TX 78411 by **May 31st**. Hard copies only.

If any medical issues change after that date, it is the responsibility of the parent/competitor to notify the Regatta Registrar, Mary Sterett (marysterett@aol.com). It is highly recommended that you bring a copy of your medical Insurance card with you.

HOUSING:

Housing is not guaranteed and you *will need to request it upon registration*. We will make every attempt to house as many sailors as possible. First priority will be given to competitors sixteen and under. Sailors traveling on their own will receive additional consideration. Additional available beds will be allotted based on date requested and distance traveled. Sailors who will be housed will receive notification on or before June 15. You will be notified of your housing placement at registration. Please remember that you will be a guest in someone's home, so no wet towels on the floor, clothes everywhere, special requests or the like.

GUEST/ ACCOMMODATIONS:

For those competitors who are not assigned private housing, or who would prefer to arrange their own local accommodations, we have a special regatta rate with the **Best Western Marina Grand Hotel** located at 300 N. Shoreline, Corpus Christi, TX 78401. 361-883-5111. This hotel is the closest to CCYC and is walking distance to the club. The event code is SAILING 2013, and the "regatta rate" of \$103.50 (including tax) is available through June 15th, but rooms are limited so book early.



MEALS:

Meals for competitors will be provided throughout the regatta. Breakfast and dinner will be served at CCYC. Build your own sandwich lunches will be served on the water. There will be heavy refreshments at the Awards Ceremony following racing on Friday.

GUEST MEALS: CCYC is a full service club. Lunch and dinner are available for purchase with a guest card.

CITY OF CORPUS CHRISTI MARINA RULES:

The City of Corpus Christi Marina is a public facility that CCYC shares with other visitors. We ask competitors to be courteous and respectful to other users. Also, we ask you to please obey posted signs and regulations as well as follow the Marina rules. Coaches should be aware of “no wake areas” inside the breakwater.

PARKING AT THE VENUE:

Parking for competitors’ cars, trailers, and guest cars will be designated by on site staff during the course of the regatta. Competitor and spectator cars may not be left overnight.

EVENT SCHEDULE and AWARDS CEREMONY:

Attendance at all post-racing dinners and events of the Youth Champs as well as the Awards Ceremony on Friday, August 16th in the afternoon is MANDATORY for all competitors.

COMPETITOR’S OWN SAILBOATS:

Competitors who intend to bring their own sailboats may not arrive at CCYC before 1200 hours on Monday, August 12th. You will be directed upon arrival where to put boat and trailer. US Sailing has set up a site for those sailors wishing to “boat pool”. You can find out more at http://championships.ussailing.org/Youth/Charters/Trailer_Sharing.htm

CHARTERS: If you applied for a charter, you will receive an e-mail directly from the charter provider if a charter is available for you. If you were not awarded a charter, there is a link on http://championships.ussailing.org/Youth/US_Youth_Champs.htm to enter in your details. US Sailing will make every effort to help you coordinate with others to bring your boat to Texas.

CREW CHANGES:

Occasionally, unanticipated situations may make it necessary for teams to change crew. Crew changes will be granted **only if** there is a valid reason (see the Championship Conditions for specifics). Sailors who wish to change sailing partners must submit a request in writing stating the reason. You will be asked to provide supporting documentation for the team member withdrawing as well as a resume for the proposed replacement. Requests should be e-mailed to the Youth Champs National Chair, Malinda



Crain, at usyouthchamps@gmail.com . We encourage you to plan well in advance in an effort to retain your original team unless a true emergency arises.

PRIVATE COACHES:

US Sailing will be providing coaches to assist all competitors participating in the Youth Champs; however, private coaches are permitted. Private coaches planning to attend must register on the event site by Sunday, July 15 at http://championships.ussailing.org/Youth/US_Youth_Champs.htm .

Please refer to NOR 1.2.3, the US Sailing Championship Support/Vessel Policy. The fee for private coaches is \$200, and includes all meals provided to competitors during the event, and dockage for a coach boat and storage of boat trailer. Housing for private coaches is NOT provided and private coaches will have to provide their own coach boats. The fee for private coaches who register AFTER July 15 will be \$300. Payment is by check to Corpus Christi Yacht Club. Private coaches must meet the criteria outlined here:

Coaches will be anchored below the starting line during racing and sailors will be free to go up to their coaches between races. Parents or spectators are not permitted on coach boats.

SPECTATOR BOATS:

It is our intent to provide spectator boats for those wishing to go on the water on race days. Parents are not permitted on coach boats. Spectators will be requested to sign up the day before they want to go on the water. Sign up will be at the CCYC Regatta Office.

Spectators are encouraged to bring their own water and lunch. No alcohol will be allowed on the spectator boats. Please bring your own personal flotation device. **NO PRIVATE SPECTATOR BOATS WILL BE PERMITTED IN THE RACING AREA.**

SAILING INSTRUCTIONS:

Sailing Instructions will be distributed at registration and preliminary Sailing Instructions will be posted online.

WEATHER:

Weather in August in Corpus Christi is hot and humid, with average daily highs in the mid-90s. Please refer to your favorite weather site for real time weather information. Hats, sun glasses, sunscreen, rash guards (for sun protection), etc. are essential. It is very important to stay hydrated.



ALCOHOL and DRUGS:

Per US Sailing Regulation 10.10.01: The use of alcohol or any illegal drug by a competitor will not be tolerated during the event. We will take any violation of this policy very seriously. Offenders will be dealt with strictly as stated in the Notice of Race. Parents and sailors should make sure that they fully understand the policy.

CURFEW:

There will be a 10pm curfew during the event, meaning that ALL competitors must be “home” where they are being housed by 10pm each night. These regulations are in effect from Monday, August 12th through Friday, August 16th. There will be no exceptions. We are not trying to make the event less fun; we are simply concerned for your safety.

TREATING THE HOST SITE PROPERLY:

The Youth Champs Organizing Committee has been planning and working on this event for many months. As the premier youth event on the 2013 sailing calendar, we take the US Youth Championship regatta very seriously. You can be assured that we have planned the best possible event for you and, as our guests, we hope that you appreciate our efforts. CCYC club rules are expected to be followed at all times. Please be as self-sufficient as possible and help others as needed. We expect that you will jump in and help without being asked!

PERSONAL GEAR:

Mark all your belongings in advance! We continually find clothes and equipment that competitors leave around throughout the event. All items with a name clearly on them usually get returned. Take a few minutes with an indelible marker and put your name on everything you will be bringing. Also, clearly paint or otherwise mark your own spars and other personal boat equipment.

WE SUGGEST THAT YOU BRING THE FOLLOWING:

- Sunscreen, sunglasses, hat, and rash guard (for sun protection)
- Tools and parts for privately owned boats
- 28-foot Tow Line (required for all boats)
- Notebook, pen, Rulebook or the app
- Personal entertainment (e.g. books, Frisbee, iPod)
- Appropriate sailing gear and clothing for hot and humid weather conditions
- Your water bottle – labeled with your name
