



**SOUTH TOWER RACE 2013**  
**Stockton Sailing Club, Stockton, CA**  
**June 21-23, 2013**

**NOTICE OF RACE**

**1 RULES:**

- 1.1 The 41<sup>th</sup> annual South Tower Race will be governed by the 2013-2016 International Yacht Racing rules as adopted by the United States Sailing Association except as altered by the event Sailing Instructions. Between the hours of sunset and sunrise, the International Regulations for Preventing Collisions at Sea, (See Appendix 9) shall apply. The Stockton Sailing Club Sailing Instructions and U.S.S.A. rules shall apply, in that order.
- 1.2 All yachts must comply with the U.S.C.G. requirements for recreational vessels, and have the following additional equipment:
- Life ring, man overboard light, and whistle, all attached as one unit.
  - A working VHF radio with channels 16 and 72.
  - Life lines or safety lines leading from both sides of the cockpit forward, well secured at each end.
  - Manual bilge-pump with minimum capacity of 10 gallons per minute.
  - Up-to-date charts of the race course.
  - A motor and sufficient fuel to propel the yacht for 3 hours at 70% of her hull speed in smooth water.

**2 ELIGIBILITY AND ENTRY**

- 2.1 Skippers of mono-hulled yachts with self-bailing cockpits who are members of recognized yacht clubs or sailing associations are eligible to participate, provided the yacht meets the following specifications:
- Minimum LOA 22' 0"
  - Maximum PHRF 275
  - Minimum Crew 3 (skipper plus 2 crew)
- 2.2 Additionally, certain multi-hulled yachts may be invited to race. These yachts will compete solely within their own division.
- 2.3 Each yacht shall submit either a current YRA or SSC PHRF certificate or a completed Stockton Sailing Club PHRF Application.

**3 FEES**

- 3.1 The entry fee will be \$80 less \$5 with proof of current USSA membership.

**4 SCHEDULE**

- 4.1 Registration: Entries will be accepted until 1900 hours on Thursday, June 20, 2013.
- 4.2 Friday, June 21, 2013
- 1000 Skipper's Meeting
  - 1055 First Warning Signal

**5 SAILING INSTRUCTIONS**

- 5.1 The sailing instructions will be available on [www.stocktonsc.org](http://www.stocktonsc.org), and at the Stockton Sailing Club clubhouse no later than Monday, June 17, 2013.

## **6 RACING AREA AND COURSE**

- 6.1 The racing area will be the Stockton Deep Water Channel/San Joaquin River, New York Slough, Suisun Bay, San Pablo Bay, Carquinez Straights, and San Francisco Bay.
- 6.2 The course is from the starting line adjacent to the Stockton Sailing Club clubhouse to Y.R.A. Mark 16 (Blackaller buoy) and back to the finish line adjacent to the Stockton Sailing Club clubhouse. Course details will be specified in the South Tower Race Sailing Instructions.

## **7 SCORING**

- 7.1 Corrected times will be computed in accordance with the PHRF time allowances as assigned by the Stockton Sailing Club Handicap Committee. All handicap allowances will be assigned by Thursday, June 20, 2013. The distance for handicap purposes will be 140 nautical miles.
- 7.2 For the purposes of assigning handicaps, yachts choosing to race using headsails with LP's of 110% or less (that would normally use headsails up to 155%), or without spinnakers (that would normally use spinnakers), will be accorded the following rating adjustments:
  - Headsails of 110% or less + 9 seconds/mile
  - No spinnaker +15 seconds/mile
- 7.3 All yachts will be assumed to use headsails from 111% to 155% or to class limit, and spinnaker, unless the race chair is notified in writing by 1900 hours, Thursday, June 20, 2013, that there will be a change.

## **8 STARTING DIVISIONS**

- 8.1 The Race Committee will assign each yacht to a starting division. Division assignments will be announced no later than the Skippers Meeting.

## **9 AWARDS**

- 9.1 Results will be announced on Sunday, June 23, 2013, at 11 a.m. in the Stockton Sailing Club clubhouse.
- 9.2 There will be awards to the top finishers in each division with the number of awards depending on the number of entries per division.
- 9.3 Additional trophies will be awarded as follows:
  - First to Finish (elapsed time)
  - First to the Weather Mark (elapsed time)
  - First Stockton Sailing Club Yacht (corrected time)

## **10 DISCLAIMER OF LIABILITY**

- 10.1 Competitors participate in the regatta entirely at their own risk. See rule 4, decision to race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
