



**Sailing Instructions**

**1. RULES**

- 1.1. The regatta will be governed by the rules as defined in *The Racing Rules of Sailing for 2013 - 2016* (RRS).
- 1.2. All competitors are required to wear a life jacket or other adequate personal floatation device while racing. This changes RRS 40.

**2. ENTRY FEES**

- 2.1. Entry fees are as follows: \$20 if received by 1900 hours Thursday, October 3, 2013; \$30 if received after
- 2.2. Late registration will be held on-site on Sunday, October 6, 2013 between 1000 and 1030.

**3. NOTICES TO COMPETITORS**

- 3.1. Official notices will be posted on the windows by the south door of South Beach Yacht Club.
- 3.2. Any changes in the Sailing Instructions will be posted by 1030 Sunday, October 6, 2013.
- 3.3. Competitors should monitor VHF Channel 78 for on the water communications with the Race Committee.

**4. SIGNALS MADE ASHORE**

- 4.1. Signals made ashore will be displayed from the flagpole located on the deck of South Beach Yacht Club. If a postponement is signaled ashore, the warning signal will be made not less than 45 minutes after flag AP is lowered. This changes Race Signals AP.

**5. SCHEDULE AND CLASS FLAGS**

- 5.1. A Competitors meeting will be held on the day of the regatta, September 16 at 1130 hours in the SBYC Clubhouse.
- 5.2. Prizes will be awarded after the racing on September 16 in the South Beach Yacht Club Clubhouse between 30 minutes and one hour after the conclusion of the scoring of the Regatta.
- 5.3. Two races are scheduled in the series as follows:

1	1300 Hours
2	Immediately after race #1

**5.4. CLASS FLAG (IN STARTING ORDER)**

**6. RACING AREA**

- 7. The race will be sailed in the South Bay Waters of San Francisco Bay located in the general area east of South Beach Harbor and around Anchorage 9.

**8. THE COURSE**

- 8.1. The marks courses and rounding are described in Appendix "A", MARKS AND CHARTLET, COURSES AND ROUNDING ORDER. Code and course flag(s) will be displayed from a staff on the Race Committee boat.

**9. THE START LINE**

- 9.1. The starting line will be between a staff displaying an orange flag on the RC boat and YRA mark "SC1"

## **10. THE FINISH LINES**

- 10.1. The finish line will be EITHER between a staff displaying an orange flag on the RC boat and YRA mark "SC1" (NOTED AS "SC1/F1" in Appendix A, Courses) OR
- 10.2. The entrance to McCovey Cove, between the north-eastern corner of Pier 48 and the green channel marker FL G 2.5s "PA" (NOTED AS "F2" in Appendix A, Courses)
- 10.3. Boats retiring before finishing shall notify the Race Committee as soon as practical either by the assigned VHF channel or 650-799-1445.

## **11. TIME LIMITS**

- 11.1. The time limit for each race is 2 hours 30 minutes.
- 11.2. A boat starting, and finishing more than 45 minutes after the first boat in their division to finish in any race will be scored DNF by the Race Committee. This changes RRS 35, A4 and A5.
- 11.3. A boat must start within five (5) minutes of the start signal for her to be scored in that race.
- 11.4. No race will start after 1600 hours

## **12. SCORING**

- 12.1. Two (2) races are scheduled, of which one (1) must be completed to constitute a series.
- 12.2. There will be no throwouts.

## **13. PROTESTS**

- 13.1. A Protest Flag may be a red bra. This changes RRS 61.1(a).
- 13.2. Protests and requests for redress shall be written on standard US SAILING Protest Forms. Protest Forms are available at South Beach Yacht Club from the Race Committee and shall be delivered to a Race Committee Representative within one hour after the Race Committee Boat returns to the dock or the Finish Line Race Committee returns from the Finish Line, whichever is later. The Race Committee Boat's or the Finish Line Race Committee's return time shall be posted on the Regatta Notice Board at South Beach Yacht Club.
- 13.3. The time and place of all protest hearing(s), the boat(s) being protested and boat(s) requesting redress shall be posted on the Regatta Notice Board at the South Beach Yacht Club within 30 minutes of the protest time limit. It is each boat's responsibility to check the Regatta Notice Board to see if they are a party to a protest or redress hearing. This shall serve as proper notification per RRS 63.2.
- 13.4. Prior to a protest hearing the party who filed the protest may make a (binding) verbal request to a PC or RC Representative that the protest be withdrawn. Once a protest has been withdrawn, it can not be reopened, appealed or redressed.

## **14. COMMERCIAL TRAFFIC AND/OR INTERFERENCE WITH OTHER VESSELS**

- 14.1. Boats shall not impede the passage of commercial vessels and shall comply with USCG Navigation Rules. If a commercial vessel has sounded five blasts, and the commercial vessel or the Coast Guard identifies the boat, the Race Committee shall protest the boat, in which case the Protest Committee shall assume that the identified boat has impeded passage of violated USCG Navigation Rules, and the identified boat shall have the burden of proving otherwise. In the case of a complaint by vessel traffic or the Coast Guard, the protest time limit shall be extended up to seven (7) days after the conclusion of the Regatta. This changes RRS 60.2(a) and RRS 61.3.
- 14.2. The South Beach Yacht Club and the South Beach Yacht Club Race Committee shall cooperate with and provide information relevant to any investigations of impeding passage or violation of USCG Navigation Rules by the Coast Guard or other governmental authority.

## **15. DISCLAIMER OF LIABILITY**

- 15.1. Boats and competitors compete in the Regatta entirely at their own risk. See RRS 4 – Decision to Race. The organizing authority, the South Beach Yacht Club, and/or any of their collective agents or representatives will not accept any liability for material damage, personal injury or death sustained in conjunction with or prior to, during or after the Regatta. ## APPENDIX A

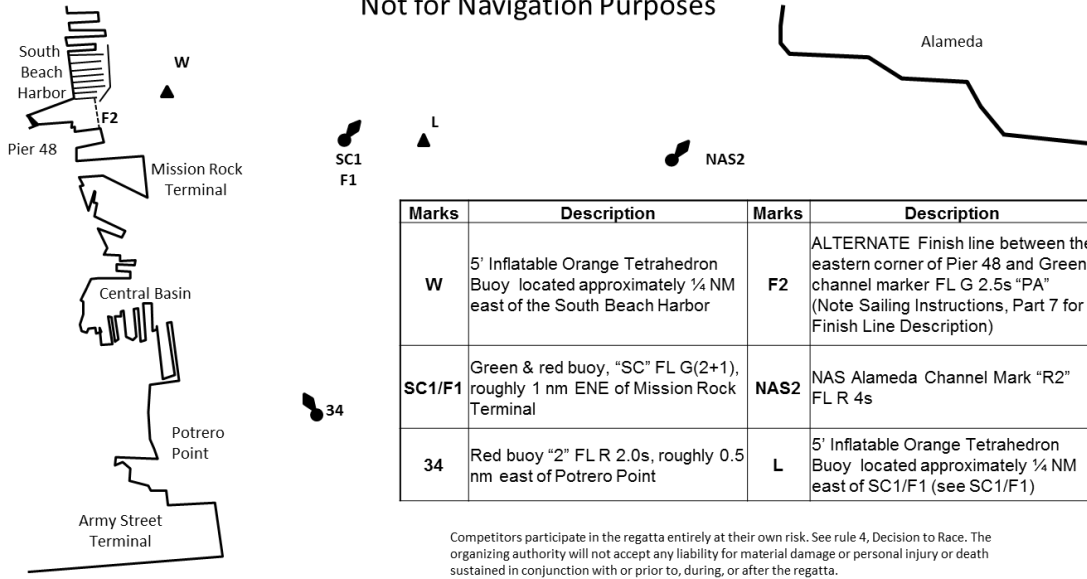
### MARKS DESCRIPTION, CHARTLET, COURSES AND ROUNDING ORDER



All rounding marks are to be passed to Port. The start line shall be between an orange flag on the Race Committee Signal Boat and Mark SC1/F1. The finish line will be between an orange flag on the Race Committee Signal Boat and Mark SC1/F1 (designated as F1 in the "Course and Rounding Order" Table), OR between the eastern corner of Pier 48 and Green channel marker FL G 2.5s "PA" (designated as F2 in the "Course and Rounding Order" Table) depending on the course.
