NOTICE OF RACE & ENTRY FORM

Spring Series: April 29th – May 13th – May 27th – June 10th – June 24th

Summer Series: July 22nd – August 5th – August 19th – September 2nd – September 16th

Champion of Champions Race for Lischeske Trophy: October 11th

The Sausalito Yacht Club invites Bay Sailors to come out for the Sunset Series. Races are held on alternate Tuesday evenings in two five-race Series. Racing will take place in the Knox / Yellow Bluff area using courses optimized for conditions. The first warning signal for each Tuesday race will be at sounded at 1830.

RULES: The Racing Rules of Sailing (RRS) shall govern this Series, designated Advertising Category A.

The low point scoring system RRS A4 shall be used. Each Series shall be scored as a Series Longer than a Regatta per RRS A9. A minimum of one race shall be completed to constitute a Series. If four or more races are completed for each Series (Spring and Summer) the score for one race will be excluded for each Series.

Trophies will be awarded to winners of individual races after each race. Series trophies will be awarded to Series entries after the last race of each Series. Single race entries are not eligible for Series trophies. There will be a "Champion of Champions" race for the Lischeske Perpetual Trophy which will be awarded at the annual membership meeting. The mono-hull Series Award winners are eligible to compete in the Champion of Champions race. A separate Notice of Race will be issued for that race.

Entry is open to all yachts with a current PHRF certificate and members of one-design fleets. Five or more one-design entries may constitute a class.

Sportboat (displacement-to-length ratio of 112 or less and waterline length of 32 feet or less; i.e., $D / (2.24 \times (LWL / 10)^3) \leq 112$ and $LWL \leq 32$ where D is displacement in pounds and LWL is waterline length in feet) and Multi-hull classes are also welcomed.

A copy of your PHRF certificate must be received by the race committee or listed on the current YRA web site (www.yra.org) to complete your registration.

Entry fee is \$130 (\$120 for members of US Sailing) for both Series and \$75 (\$70 for members of US Sailing) for one Series (Spring or Summer). Single race entries are \$25.
