



NOTICE OF RACE CATALINA22 2014 NATIONAL CHAMPIONSHIP

June 22 – 26, 2014

Lakewood Yacht Club, Seabrook, Texas

1. RULES

The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* and Catalina 22 One Design Rules.

2. ELIGIBILITY AND ENTRY

2.1 Participation in the capacity of skipper/helmsman shall be limited to owners of Catalina 22 sloops (and their immediate families) who are members of the Catalina 22 National Sailing Association in good standing.

2.2 Eligible competitors may enter by completing the entry form and remitting the required fees. Online registration is available at the Lakewood Yacht Club website www.lakewoodyachtclub.com. Checks should be made payable to Lakewood Yacht Club and mailed to:

3. CLASSES

There will be two class fleets:

Genoa Gold Fleet Open to all skippers eligible to sail the Regatta. The winner will be the 2014 National

Champion

Genoa Silver Fleet Limited to skippers who have not received a first place trophy in any Catalina 22 state,

regional or national regatta.

Spinnaker Fleet Must also be registered in either Gold or Silver Fleet.

4. FEES

- 4.1 The entry fee is \$160.00 for Genoa fleet (Gold, Silver), an additional fee of \$20 for the Spinnaker fleet.
- 4.2 The entry deadline is June 1, 2014 at midnight. After that that date, a late fee of \$75.00 will be assessed.
- 4.3 Late entries will not be accepted after 1630 on June 22, 2014.
- 4.4 The entry fee includes the skipper. A Hospitality Fee of \$20.00 is required for each additional crewmember and/or guest. Fees include admittance to all parties and functions.
- 4.5 The Registration Form will be published in the March 2014 issue of *MainBrace* magazine and available on the LYC website (www.regattanetwork.com) and the Catalina 22 National Association Website (www.catalina22.org) after February 1, 2014. Early registration will close on June 1, 2014. Receipt of registration will be determined by the postmark on the envelope or when received by the Registrar if hand delivered.
- 4.6 Registration will require proof of insurance at check in.
- 4.7 Skipper and crew will be required to sign a liability release prior to racing.

6. MEASUREMENT

- 6.1 Each boat shall produce a valid Measurement Certificate before the close of check-in/registration at 1600 June 22, 2014
- 6.2 All sails must be measured according to C22 One Design Rules, available online at the Catalina 22 website.
- 6.3 Section H (Required Safety Equipment) of the C22 One Design Rules will be enforced. All boats may be inspected for compliance. An inspection may be performed at any time during the regatta.

7. SAILING INSTRUCTIONS

The sailing instructions will be available after June 1, 2014 on www.regattanetwork.com and the Catalina 22 websites (www.catalina22.org) and provided in the Skipper's Packet at the Registration Desk at the LYC.

8. VENUE

The racing area will be located in Galveston Bay or Clear Lake

9. COURSES

The courses to be sailed will be Windward/Leeward with an offset mark and gate.

10. SCORING

- 10.1 The Low Point Scoring System of Appendix A will apply.
- 10.2 More than seven races may be scheduled for the Gold and Silver Fleet with three races constituting a Regatta. Four races will be scheduled for the Spinnaker Fleet with one race constituting a Regatta.

11. BERTHING AND HAUL-OUT

- 11.1 All boats must be launched by 1600 on Sunday, June 22 and remain in the water unless written permission is granted by the race PRO.
- 11.2 Catalina 22s will be trailer launched.
- 11.3 Dry berthing will not be available. All boats must remain in the water from 1600 Sunday until the conclusion of racing for this event.

12. PRIZES

- 12.1 Prizes will be awarded to the top five (5) boats in each fleet with five boats or more.
- 12.2 The Betty Gay Clements perpetual trophy will be awarded to the highest placing female skipper in accordance with its deed.
- 12.3 The Dick King Memorial trophy for the highest place Sport will be presented.





13. DISCLAIMER OF LIABILITY / WAIVERS

- 13.1 No boat shall participate in this regatta unless the skipper and all crew members have submitted a Waiver and Release of Liability prior to the Skippers Meeting. At the discretion of the Race Committee Chair, crew member waivers may be accepted after the Skippers Meeting but prior to the race start. Failure to submit a waiver for each crew member will result in the entry being incomplete and the boat will not be considered to be participating in the event. This changes RRS 82.

13.4 It is the skipper's obligation to ensure that each crew member's waiver is reflected on the waiver list prior to check in on race day to verify that the boat has met the entry requirement.
