Racing rule(s) 26, 29.2, 29.3, 31.2 and 44 will be changed. The changes will appear in full in the sailing instructions.

Racing yachts encountering any non-racing vessels shall conform to the Rules of the Road. No vessel has right of way over a large ship in the channel (COLREGS, Rule 9). Interference with deep draft vessels will be grounds for disqualification.

#### Entries.

Entry is limited to members of yacht clubs and associations recognized by USSA, SCYA, SDAYC or their own National Authority.

#### Prizes


One pennant each will be presented for boat finishing in 1st, 2nd, and 3rd place.
