## Notice of Race - Revised

### Rules

The regatta will be governed by the *Rules* as defined in the 2013-2016 Racing Rules of Sailing (Appendix BB), the Sailing Instructions and this Notice of Race, the IKA Point System and Code of Conduct.

### Eligibility

This regatta is open to all competitors in any discipline with no limit on the number of competitors. Parental/Legal Guardian assent is required for those under 18.

### Entries

The entry fee will be \$40.00. Competitors may enter online at:

Entry fees will be refunded if the entry is withdrawn prior to the entry deadline. The deadline for all entries is Saturday, ~~March 22~~ **Oct. 4**, 2014 at 0930 CST. Entries can be made on Regatta Network, by mail or cash on the day of event.

### Courses

Courses will be Freestyle and Course events or a combination of; located in that part of Galveston Bay around the Texas City Dike and Texas City Levee in Texas City, TX.

## **Scoring**

Low point scoring system shall apply. No races will be excluded from scoring. This Modifies RRS A4. One completed race constitutes a regatta .

## **Schedule of Events**

A Competitors Briefing will be held between at 9am on the levee at Texas City dike the morning of the event, Saturday ~~March 22~~ **Oct. 4**, 2014, unless otherwise posted. As many events as practical will be run during the regatta. Subsequent races for each class will be started as soon as possible after the class has finished the prior race. The warning signal for the first race for each day of the regatta will not be before 1000 hours. Following the conclusion of the days races, awards presentation and festivities including food and drinks will be held on Saturday, ~~March 22~~ **Oct. 4**, 2014.

In the event of no wind on Saturday, all events will postponed to Sunday, ~~March 23rd~~ **Oct. 5**, 2014.

## **Equipment & Buoyancy**

Bring your own kite board, flotation and helmet. Flotation jackets will be required should there be a downwind slalom course. Helmets are required for all competitors. (No Helmet = No Score). Storage of equipment will not be provided.

## **Support Boats**

Support boats will be available displaying a flag that indicates they are a part of the event. This will be defined at the competitors briefing.
