# SAILING INSTRUCTIONS



**NATIONAL BUTTERFLY ASSOCIATION**  
**2014 JUNIOR & OPEN NATIONAL CHAMPIONSHIPS**  
**July 15 - 17 — Glen Lake — Glen Arbor, Michigan**

- 1 - Rules** — the regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS).
  
- 2 - Notices To Competitors** — will be posted on the official notice board located on the deck of the GLYC.
  
- 3 - Changes to Sailing Instructions** — Any change to the sailing instructions will be posted no later than ninety (90) minutes prior to the first scheduled warning signal of the day, except that any change to the schedule of races will be posted by 1800 hrs on the day before it will take effect.
  
- 4 - Signals Made Ashore** —
  - 4.1** - Signals made ashore will be displayed from the dock and/or deck of the GLYC.
  - 4.2** – When Flag AP is displayed ashore, ‘1 minute’ is replaced by ‘thirty (30) minutes.’ This changes RRS Race Signal AP.

- 6 - Class Flag** — will be a black butterfly on a white background.
- 7 - Racing Area** — will be Glen Lake, located in Western Leelanau County near Glen Arbor, Michigan.
- 8 - The Courses** — will be as follows (see Attachment 2) and will be signaled by flag and/or sign board on the RC Signal Boat prior to or with the warning signal for each race.
- 8.1** - Windward/Leeward - consisting of 3 or 4 legs and signaled by sign board and/or flags '3' or '4'.
  - 8.2** - Triangle - consisting of 5 legs (triangle, windward, leeward) and signaled by sign board and/or flag 'T'.
  - 8.3** - All marks shall be rounded to port, except in the case of a leeward gate (7.4) and courses 4 & T Finish Mark.
  - 8.4** - An Offset Mark (Mk Os) may be used at the Weather Mark (Mk W) when it is followed by a leeward leg.
  - 8.5** - A Leeward Gate (Mks Ls & Lp) may be used at the end of a leeward leg. When used, boats shall sail between the marks and round either mark. (see Attachment 1)
  - 8.6** - Courses will not be shortened. This changes RRS 32.



# SAILING INSTRUCTIONS



*(Continued from previous page)*

## **9 - Marks —**

- 9.1** - Primary marks W, L(Ls/Lp), & R will be large orange rounds.
- 9.2** - The windward offset mark, Os, will be a small orange round.
- 9.3** - Changing marks, as in SI 10, will be large yellow cylinders.
- 9.4** - The start mark will be 4' Orange Cylinder w/ a Yellow Band.
- 9.5** - The finish mark will be a 3' Yellow Cylinder.

## **10 - The Start —**

- 10.1** - The starting line will be between a staff displaying an orange flag on the RC boat at the starboard end and the course side of the starting mark at the port end. The line will be located to leeward of the leeward mark(s).
- 10.2** An automated horn system will be used for all starts. All warning signals will be preceded by a series of 'short toots' one (1) minute prior to. (This will also accompany AP down and General Recall down.)
- 10.3** - Individual and general recalls will be signaled in accordance with rule 29. The following are not grounds for redress: failure of committee to hail any or all boats; failure of committee to accurately hail one or more boats; failure of a boat to hear its hail; timeliness of the hail; or the order of boats within the hail.
- 10.4** Any boat starting later than five (5) minutes after her starting signal will be scored Did Not Start (DNS).



# SAILING INSTRUCTIONS



*(Continued from previous page)*

**11 - Change Of The Next Leg Of The Course –** To change the next leg of the course, the race committee will lay a new mark (or move the finishing line) and remove the original mark as soon as practicable. When in a subsequent change a new mark is replaced, it will be replaced by an original mark.

## **12 - The Finish —**

**12.1** - For Course 3, the finishing line will be between a staff displaying an orange flag on the RC boat at the starboard end and the course side of the nearby finishing mark at the port end and will be located to windward of the weather mark.

**12.2** - For courses '4' & 'T' the finishing line will be reversed with the RC boat on the port end and the finish mark on the starboard end and will be located to leeward of the leeward mark(s). See Attachment 2.

## **13 - Time Limits —** this changes RRS 35 and A4.

**13.1** - The time limit for any race will be sixty (60) minutes.

**13.2** - Boats not finishing within twenty (20) minutes of the first boat to finish will be scored Did Not Finish (DNF) and will receive one more point than the last boat to finish.

**13.3** - If no boat has reached the first mark within twenty (20) minutes, the race will be abandoned.



# SAILING INSTRUCTIONS

## **14 – Protest and Requests for Redress –**

- 14.1** – Protest forms will be available at the Official Notice Board and shall be delivered there within the protest time limit.
- 14.2** – The protest time limit is sixty (60) minutes after the RC boat docks. This time will be posted on the Official Notice Board.
- 14.3** – Notices will be posted within thirty (30) minutes of the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held at GLYC.
- 14.4** - On the last day of the regatta, a request for reopening a hearing shall be delivered –
  - a)** Within the protest time limit if the party requesting reopening was informed of the decision on the previous day, or
  - b)** No later than thirty (30) minutes after the party requesting reopening was informed of the decision on that day. This changes RRS 66.

## **15 – Scoring –** (This applies to both the Junior and Open Championships)

- 15.1** - Six (6) races are scheduled for each division of which one (1) race shall be completed to constitute a series.
- 15.2** - When fewer than five (5) races have been completed, a boat's score will be the total of her race scores. This changes RRS App A2.

**16 – Safety Regulations** - A boat that retires from a race or leaves the racing area shall notify the RC by hailing any RC boat or by notifying RC personnel at the GLYC.

**17 - Equipment and Measurement Checks —**  
Equipment may be checked at any time prior to the end of the protest period for the last race for compliance with the NBA Rules by the Jury, at the direction of the NBA.

**18 - Prizes —** in addition to the perpetual trophies, the following trophies will be awarded:

**Junior Skipper:** 1<sup>st</sup> through 10<sup>th</sup> Place

**Junior Crew:** 1<sup>st</sup> through 10<sup>th</sup> Place

**Open Skipper:** 1<sup>st</sup> through 5<sup>th</sup> Place

**Open Division:** 1<sup>st</sup> Place Woman

**Junior Division:** 1<sup>st</sup> Place Woman

**Tune Up Race:** 1<sup>st</sup> Place Skipper

**Tune Up Race:** 1<sup>st</sup> Place Crew

**Youngest Skipper**

**1<sup>st</sup> Place Master**

**2<sup>nd</sup> Place Master**

**3<sup>rd</sup> Place Master**

**19 - Disclaimer Of Liability —** Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

**20 - Insurance** — Each participating boat shall be insured with valid third-party liability insurance.

## Attachment 1 — GATE MARK ROUNDING

When there is a gate at Mark L, boats shall sail between the gate marks from the direction of the previous mark and round either mark.

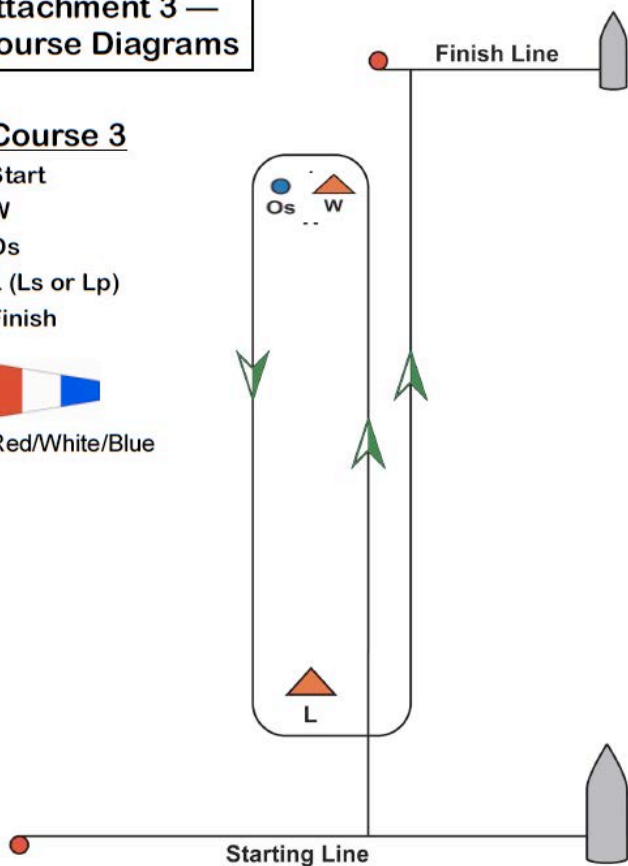

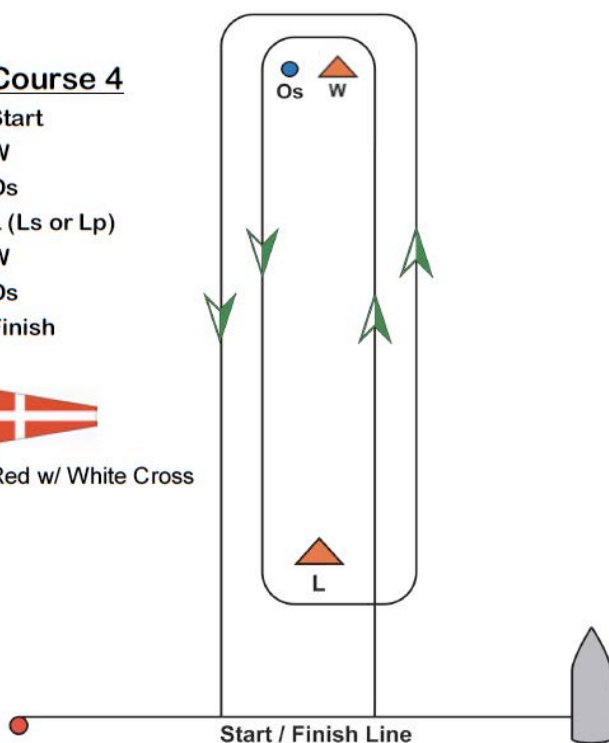
