NOTICE OF RACE

Lipton Challenge Cup One May 3rd & 4th, 2014

1. RULES:

- 1.1. The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*, the prescriptions of US SAILING, the Waikiki Yacht Club Standing Sailing Instructions, the Hawaii Maritime Center Historical Trophies Advisory Board (HTAB) Notice of Challenge and Authorization to Award #15 dated February 3, 2014, this Notice of Race and the Sailing Instructions.
- 1.2. The Racing rules will be changed as follows:
 - 1.2.1. Rule 55 does not apply for spinnaker stopping materials only. It still applies to trash.
 - 1.2.2. Rule 60, 63.2 and 63.4 do not apply.

2. ADVERTISING: Advertising will not be restricted.

3. ELIGIBILITY AND ENTRY

- 3.1. The regatta is open to yachts that meet the challenge and eligibility requirements as defined by the HTAB Authorization to Award, the Notice of Challenge, and the entry requirements as published in this Notice of Race
- 3.2. Yachts shall have a HYRA valid PHRF rating and submit a certificate to WYC by **April 19, 2014**
- 3.3. Entrants will submit a copy of their yacht's insurance certificate at the skippers meeting
- 3.4. Eligible boats may register by attending the skipper's meeting
- 3.5. Per the Authorization to Award, skippers will submit a crew list at the skipper meeting with the following information: Name, State of Residency, and the Date joined representative club.

4. FEES: The entry fees will be \$200.00 payable to Waikiki Yacht Club before or at the Skipper's meeting

5. SCHEDULE:

- 5.1. Skippers' Meeting: 1800 Thursday May 1st 2014
- 5.2. First Warning: 1055 Saturday May 3rd 2014
- 5.3. First Warning: 1055 Sunday May 4th 2014
- 5.4. Number of Races: 5 Races are scheduled

6. SAILING INSTRUCTIONS: The Sailing Instructions will be available at the Skippers Meeting

7. VENUE: The Course Area will off the south shore of Oahu

8. COURSES: Courses will be displayed by the Race Committee at or prior to the warning of the race as described in the Sailing Instructions

9. SCORING: The scoring system is as follows:

- 9.1. PHRF Handicap rating systems as endorsed by HYRA using Time-on-time
- 9.2. A minimum of three races is required to constitute a series
- 9.3. There will be no throw-outs. This modifies Rule A2

10. PRIZES: Prizes will be presented at the awards ceremony after the event. The Sir Thomas Lipton Challenge Cup One Trophy will be awarded to the winner of the series based on the conditions of the Authorization to Award #15

11. **DISCLAIMER OF LIABILITY:** Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
12. **INSURANCE:** Each yacht shall be insured with valid third-party liability insurance with a minimum coverage of \$300,000 per event or the equivalent.
