1. RULES

The sailboat races will be governed by the 2013-2016 Racing Rules of Sailing (RRS) with US Prescriptions and The Leukemia Cup Regatta Sailing Instructions, which will be available at the Skippers Meeting. Ocean Springs Yacht Club and Singing River Yacht Club will administer the Race.

2. FLEETS

BEACH CATAMARANS: Four valid entries are necessary to establish a class.

KITEBOARDS: Four valid entries are necessary to establish a class.

PADDLEBOARDS: Four valid entries are necessary to establish a class.

KAYAKS: Four valid entries are necessary to establish a class.

3. RACE FORMAT & LOCATION

Beach Cats: Distance Race from Ocean Springs Yacht Club to Singing River Yacht Club

Kite Boards, Paddleboards, Kayaks: Race locations will be determined by the classes.

4. ADVERTISING

The OA may require boats display event or sponsor advertising chosen and supplied by the OA in accordance with ISAF Regulation 20.4. Competitor advertising, if used, shall comply with ISAF Regulation 20, especially 20.2.4.

5. ELIGIBILITY

Competitors: The race is open to all. Competitors need not be a member of a Yacht Club.

6. ENTRY FEES
