The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS).

Appendix T, Section A, T1 (One-Turn Penalty) shall apply.

The intended racing area will be the Knox area. Courses will be windward/leeward courses set up using inflatable marks.

Warning Gun will be at 1130 hrs. Three races are scheduled.

The low point scoring system RRS A4 shall be used. A minimum of one race shall be completed to constitute a series. All races count. This changes RRS A2.
