We realize that if we give false or misleading information in this Declaration for the Corinthian Division, we may be subject to a hearing under RRS 2 and/or RRS 69, Suspension/Expulsion under paragraph 8 of the USMCA Constitution, and the helm may be disqualified from earning points for any USMCA Ranking Event for a period of one year.
